Sheridan road and County Line road was denied.

#### To Sell Tract

Commissioner Gourley moved that the corporation counsel be instructed to prepare an ordinance providing for the sale of the city's twenty-five acre tract of land on Clavey road to the highest responsible cash bidder.

Commissioner Reay moved that the Chicago North Shore and Milwaukee Railroad company be granted a permit to operate the bus route in accordance with their request therefor, subject to such written guarantees as can be obtained by the corporation counsel to discontinue or change said route if requested to do so by the council.

Commissioner Zimmer moved that the ordinance providing for the rezoning of Lot 8 in Block 22, known as the Decker property be referred to the zoning committee. Commissioner Brown moved that the council take a recess and convene as the board of local improvements.

After the meeting of the board of local improvements, the council reconvened, the following members being present: Mayor Lewis, Commissioners Brown, Gourley, Reay and Zimmer.

Commissioner Gourley moved that Mr. Geo. L. Vetter be appointed the officer to spread the assessment providing for a connected system of water mains in Geo. F. Nixon's Woodridge subdivision, Highland Park Special Assessment No. 332. The motion prevailed. Yeas: Mayor Lewis, Commissioners Brown, Gourley, Reay and Zimmer. Nays: None.

#### Vote Is Divided

Commissioner Gourley moved that Mr. R. E. Clark be appointed the officer to spread the assessment providing for a connected system of water mains in Geo. F. Nixon's Highland Park Acres subdivision, Highland Park Special Assessment No. 324. The motion lost. Yeas: Mayor Lewis, Commissioner Gourley; Nays: Commissioners Brown, Reay and Zimmer.

Commissioner Gourley moved that Mr. Geo. L. Vetter be appointed the officer to spread the assessment providing for a connected system of water mains in County Line road, Highland Park Special Assessment No. 323. The motion prevailed. Yeas: Mayor Lewis, Commissioners Gourley, Brown, Reay and Zimmer; Nays: None.

#### Another Division

Commissioner Reay moved that Mr. Frank Laing be appointed the officer to spread the assessment providing for a connected system of water mains in Geo. F. Nixon's Highland Park Acres subdivision, Highland Park Special Assessment No. 324. The motion prevailed. Yeas: Commissioners Brown, Reay and Zimmer; Nays: Mayor Lewis and Commissioner Gourley.

The board of local improvements submitted an ordinance providing for the construction of a connected system of cast iron water mains in McCaren road, Edgewood avenue, Glenwood avenue, Eastwood avenue, Cloverdale avenue, Little John court, Friar Tuck avenue, Lancelot avenue, Robin Hood place, Arbor avenue, West Park avenue, Sunnyside avenue, Grandview avenue, Midway avenue, a forty (40) foot street between Lot 41, J. S. Hovland's Highland Park Acres subdivision and the east line of the SW 1/4 of section 21, township 43 north, range 12 east of the 3rd principal meridian, and Ridge road. Commissioner Gourley moved that the ordinance as read remain on file with the city clerk for public inspection complete in form until its final passage.
