Interesting Happenings About This Part of North Shore and Vicinity; County Seat Doings

Frederick Keith Fitch, 56, of 411 Julian street, died at 6:10 o'clock this morning at the Lake County General hospital from injuries he received late Friday afternoon when he was struck by an automobile near the hospital.

Dr. F. C. Knight, active in Victory Memorial hospital staff work for the past several years, last week was unanimously elected president of the hospital board for the coming year.

Mrs. C. Upton, widow of the late Attorney William C. Upton, for years one of the leading attorneys of Waukegan and northern Illinois, died at the home of her niece, Mrs. Charles O. Jordan of Evanston.

As a result of the success attained in the local work of the American Legion, the eighth district, comprising Lake County, is leading the state in membership and the county has already attained the quota assigned to it by the state for 1928.

William Kubker, aged 75 years, a resident of Lake county for nearly 70 years, died at the home at Ivanhoe, last week, after a lingering illness. The deceased was prominently known in that section of the county.

April 16 today was set as the conference date for the Lake Shore division of teachers, according to T. A. Simpson, county superintendent of schools. This will include Chicago, Evanston and all lake shore cities. The meetings are to be held in the high school. Plans for entertaining 2,500 are being made.

John S. Whyte, manager of the Champion Folding Furniture company and long connected with commercial and industrial interests in Waukegan, was elected as civic-social secretary of the Waukegan and North Chicago Chamber of Commerce at the special meeting of the board of directors of that association, Thursday afternoon of last week.

EXPLAINS WHY DEEP WATER WELLS FAIL

Many deep water wells in Illinois have been abandoned because the water "went down in the hole," so that the cost of pumping from the lower level became excessive. The cause of this lowering of water level is being investigated by the State Water Survey in a systematic study of water supplies for municipal and industrial uses throughout Illinois.

Measurements of the discharge of wells and the lowering of water levels in wells are made by the engineers, and samples of water are collected for analysis by chemists in the laboratory of the Water Survey at Urbana. In co-operation with local officials the changes in quantity and quality of water and in water levels are determined at selected wells in various parts of the State.

The water levels in deep wells in northern Illinois have been found to be "going down" in recent years. A large part of the lowering is due to increased pumping, and an effort has been made to determine the quantity of water pumped from wells penetrating the lower water-bearing strata, including the St. Peter sandstone and all lower strata.

PLAN TO STANDARDIZE BANKING PRACTICES

Standardization of banking practices in Illinois will result from the establishment of clearing houses in districts of the Illinois Bankers' association, according to J. K. Appel, president. The plan was approved a few days ago by the administrative committee and council of the association.

Dr. Carolyn Hedger, Mrs. Symonds and Others Speak at Meeting Tuesday

The Nineteenth District of the Illinois Council of Parent Teachers Associations held the semi-annual meeting at the Christian church in Waukegan, Tuesday.

Mrs. J. E. Edmonds, of LaGrange, the Regional Director, varies her programs so that no two are alike. Lake County Superintendent of school, T. Arthur Simpson voiced his appreciation of what the Parent Teacher Associations had done for the schools under his jurisdiction, and said that they were making it possible for every child to have a good school home, and proper tools for education.

"In a county rich in possibilities and in resources, teachers should be obtained who set before the children high ideals." Dr. Carolyn Hedger, a dynamic speaker told in no uncertain terms, what she thought of little children being trained for elaborate programs to present to adults, thus making a "Roman holiday" to the detriment of their bodies and minds.

Mrs. Symonds, of Hinsdale, first Vice President of the Illinois Council of P. T. A. spoke on "Ten Weeks in the President's Chair," her experiences during the absence of the State President in Europe.

The stupendous amount of work expected of our state officer was outlined as keeping office hours, warding off designing persons who would "work us" especially in trying to secure the mailing list (for advertising purposes) for which fabulous sum has been offered, and holding conferences all over the state.

Mrs. Symonds crystallized the feeling that we must have the work of the state departmentalized, so that there will be no such great burden on the next president. There are now one hundred thousand members in Illinois.

Mrs. Walter Buhlig, the State President announced that the major purpose of the P. T. A. is child study, and that on the twenty-fourth of February, Mrs. Chartres will conduct an all day school of instruction on the South side, which the Chicago papers will announce.

Friday afternoons during February at 4 p. m., Mrs. Cass Brown, our State Parliamentarian, will give talks over the radio.

The Illinois Council of P. T. A. annual conference will be held in Streator, Ill., April 24, 25 and 26. Each association is entitled to three delegates. Every local association is urged to pay the expenses of at least one delegate. Community leaders, and potential ones, should be the delegates.

The National Convention will be held in Cleveland in May, Illinois is entitled to one hundred delegates. Mrs. Buhlig closed her talk with a statement of what the five cents of each membership fee paid to the National does for rural schools, and for the demonstrations in the West.

Individual associations profit because of fine state leadership and on account of the prestige of the whole movement. Quoting Dr. William B. Owen, President of the Chicago Normal College "Next to Religion the Parent Teacher Association is the most important thing in the community."

OLD GLENVIEW HOTEL DAMAGED BY FIRE

John Dilg House, Landmark in North Shore; Loss About \$20,000.00

At noon Tuesday of last week eight fire companies were called out to combat the blaze in the John Dilg hotel in Glenview. After four hours fighting the companies succeeded in getting the blaze under control, but not until it had done \$20,000 worth of damage to the two upper floors.

The hotel is an old land mark in Glenview and vicinity, having been built in the early eighties. It is one of the first hotels built along the North Shore. Much damage was done by the water. The extreme cold forced the men to work under great difficulties. Much of the contents was saved.

Among the patrols called out were Glenview, Niles Center, Wheeling, Northbrook and Morton Grove.

KNOW ALL MEN BY THESE PRESENTS, That the Highland Park East Park District, in the County of Lake and State of Illinois, a body corporate, duly organized and existing under the laws of the State of Illinois, do hereby certify that the following is a true and correct copy of the Ordinance of the Board of Park Commissioners of said District, passed on the 15th day of February, 1928, with interest thereon from the date hereof at the rate of four per centum (4%) per annum, payable semi-annually on the 15th day of February and August in each year, on presentation and surrender of the unexpired interest coupons which severally become due. Both principal and interest of said bonds are hereby made payable at The Highland Park State Bank, Highland Park, Illinois.

This bond is one of a series of bonds of like date and tenor, except as to date of maturity, issued for the purpose of providing funds for the payment of land condemned, or to be condemned, or purchased, or to be purchased, for parks or boulevards, or both, for the building, maintaining, protecting and improving of the same, and for the payment of expenses incident thereto, in and for said District under the authority of an Act of the General Assembly of the State of Illinois entitled "An Act to provide for the organization of park districts and the transfer of abandoned lands to such bodies or to navigable bodies of water," approved June 24, 1905, and the several amendments thereto. And it is hereby certified and recited that all acts, conditions and things required to be done precedent to and in the organization of the Highland Park East Park District and in the issuing of this bond have been done, and have been performed in regular and due form and in accordance with law; that a continuing direct annual tax has been levied upon all the taxable property in said District for the principal and interest of this bond; and that the total indebtedness of said Highland Park East Park District, including this bond, does not exceed any constitutional or statutory limitation. IN TESTIMONY WHEREOF, The Highland Park East Park District, acting by its Board of Commissioners, has caused this bond to be signed by the President and Treasurer and attested and countersigned by the Secretary of its Board of Commissioners, with his seal of office affixed, and has caused the annexed interest coupons to be executed with the lithographed fac-simile signature of said officers, this thirteenth day of February, 1928.

President Treasurer Secretary (Form of Coupon) On the Thirteenth day of February, 1928, I, the Highland Park East Park District, promise to pay to bearer at the Highland Park State Bank, Highland Park, Illinois, being semi-annual interest due on that date on its Park Bond dated February 13, 1928, Number...

SECTION 3. That for the purpose of providing for the payment of principal and interest of said bonds as same become due and payable, there shall be and there is hereby levied a continuing direct annual tax upon all the taxable property in the Highland Park East Park District sufficient to pay the principal of and interest on said bonds as same mature, and that there be and is hereby levied a tax upon all of the taxable property in said Park District sufficient to produce the following sums for the following years, respectively:

SECTION 4. That a certified copy of this ordinance be filed in the office of the County Clerk of Lake County, Illinois, and such Clerk shall annually compute the rate necessary to produce the foregoing sums in the foregoing year.
