MOSQUITO ABATEMENT WAR ON NORTH SHORE

Operations Now in Full Swing From County Line South, Director Says

The mosquito warfare, preparations for which have been underway for a long time, is now in full swing, according to Superintendent William Edwards of the North Shore Mosquito Abatement district.

A crew of fourteen men is working south from County Line road to Howard street, Evanston, the southern limits of the district, draining and oiling. These men are under the Mosquito Abatement district, and their number is being gradually augmented, the plan being to use the recruits, as soon as they become familiar with the work, to go into other sections of the territory, including the villages, on special cases, where the trucks cannot do the work.

Four special oil trucks, each with 300 gallon capacity, the truck company announces, will be ready for delivery May 20. Each truck will be manned by a driver and a helper. Truck No. 1 will be assigned to the territory between the south line of Evanston to Lake street, Wilmette; truck No. 2 will operate from Lake street to the County line; truck No. 4 will supply oil to any point in the district, where needed.
