for this unusually large overdraft. He believes that it is most unfair not to be able to accept pay patients, but the court has so ruled and it appears that little can be done at this time to help out the situation.

"Since the court ruling became public many people have taken advantage of Lake county, that is people who can afford to pay and have received treatment at the county hospital without having to pay for it," declared Mr. Vercoe.

Poor Claims Overdrawn

The sum of \$50,000 was appropriated for poor claims and \$60,048.73 spent, there being an overdraft of \$10,048.73.

The other funds in which there are overdrafts and the amounts follow: Inquest fees \$369; foreign witnesses \$124.90; coroner's fees, \$1,120; court reporter fees, \$626; mother's pension, \$1,060; blind pension, \$568.75; committee work and mileage, \$40.35; jail account, \$1,813.47; birth and death, \$86; fees county officers, \$2,312.35;

salaries, \$4,878.30; stationery and supplies, \$12,821.57.

The funds having balances and the amounts follow:
