BANNOCKBURN VOTES TO BECOME VILLAGE

Election Saturday Favors Incorporation; Choose Officers April 16

Bannockburn, with an area of two square miles and a population of 140 persons, is Lake county's newest village, as a result of an election held Saturday, in which the proposition to incorporate was caused by a vote of 46 to 16.

The election result was certified to County Judge Perry L. Persons at Waukegan on Monday, and he set the village election for choice of officers of the new municipality for April 16.

Other Villages in County

The addition of Bannockburn brings the total of villages of 15 and the cities to six, making 21 municipalities altogether.

The villages are Bannockburn, Gurnee, which is just a year old, Antioch, Barrington, Deerfield, Fox Lake, Grayslake, Lake Bluff, Lake Villa, Lake Zurich, Libertyville, Mundelein, Round Lake, Wauconda, and Winthrop Harbor. Cities are: Highwood, Highland Park, Lake Forest, North Chicago, Waukegan and Zion.

Bannockburn is not to allow roadhouses or highway stands.

More than \$1,000,000 in public improvements have been constructed there already.

N. S. Sanitary Dist. To Be Aided By Bill Before Legislature

A bill which will both provide for the erection of a \$500,000 sewage disposal plant in Waukegan and like wise validate the formation of the North Shore Sanitary district and legalize the construction of the eight existing disposal plants built under the direction of the board has been presented in the state legislature by Representative Lee McDonough of Waukegan.

The big disposal plant in Waukegan will be erected this year if the measure is passed and the plans of the sanitary district are carried out. The plant according to present plans will be located at the foot of South avenue and it will take care of the sewage from the south side of the city.

Although formed in 1914 the validity of the district has been questioned on the grounds that the district was originally authorized to erect but one plant, according to the Waukegan Sun. It was found, however, that the erection of separate plants at Waukegan, Zion, North Chicago, Lake Bluff, Lake Forest, Highwood, Deerfield avenue and Park avenue in Highland Park would assure greater efficiency in operation. It is also stated that the original order and petition organizing the district failed to outline jurisdictional facts.

The bill of Representative McDonough will quiet these objections.

The principal object of the movement is to validate the erection of the plant in Waukegan, it is said.

County Association of Contractors Meet Here; Banquet and Program

The regular semi-monthly meeting of the Lake county Associated Building Contractors was held at the Green Tea Pot Thursday, evening, March 21. The banquet was at 6:30 p. m., and the business meeting followed. About 50 were in attendance with each town of the county represented.

Meeting was called to order by the president, Chas. Crapo of Waukegan. After thanking the Highland Park members for their splendid turn out of members for this meeting and the well arranged banquet, he introduced Joe Cabonargi of Highland Park, who acted as chairman of the meeting. Mr. Cabonargi is vice president of the association.

There was discussion on taking the plumbers and steamfitters into the association and this was agreed upon.

All members indorsed the present House Bill No. 136 which is now being debated in the state legislature. The epitome of this bill is: If any contractor comes into any community to do contract work he must pay the prevailing wage scale in that community whether his laborers are union or non-union.

Plans were made for the entertainment of the delegates that will be in attendance at a convention of the second district of the Associated Building Contractors of Ill. This convention is to be held at Waukegan, March 28, 1929 in the Masonic Temple; 400 delegates are expected. The 2nd district includes all northwestern Illinois excluding Cook county.

A. S. Weeks, of Peterson & Weeks Construction Co., of Waukegan, urged all members to attend the convention. Mr. Weeks is secretary of the Lake county association. Louis Harter, business secretary, outlined the program of the convention.
