#### Bill Would Give Aid in Cities' Road Work

Maintenance and improvement of streets in cities and villages which have been designated as a part of the state highway system is provided in a bill introduced into the lower house by Representative Chiders, of Joliet.

Under this measure, if it becomes a law, the state highway department might be required to repair certain streets in the city designated as a part of the state highway system.

The measure is aimed primarily as an aid to smaller cities and villages, but may also be a help for larger municipalities.

The care of the roads is to be made by the state from funds received from the gasoline tax law. The new measure is said to have the backing of a majority in the state house and senate.
