## BRIEF NEWS ITEMS FROM LAKE COUNTY

Interesting Happenings About This Part of North Shore; County Seat

Breaking of a flange of a wheel which resulted in the derailment of 10 cars on a Waukegan bound freight train near Diamond Lake last week, resulted in tearing up more than 2,000 feet of track and blocked all traffic on the E. J. & E. railroad for more than 16 hours.

. Frank Gabala, former North Chicago motorcycle patrolman, will be one of the four highway patrolmen to be added to the sheriff's force June 1, it was reported last week. Gabala resigned from the North Chicago force about two years ago and until recently operated a resort at Cross Lake, Wis.

## Radio Range Beacon Installed on Airway; Other Improvements

Engineers of the Airways Division of the department of commerce are constructing a radio range beacon at Goshen, Ind., which with the marker beacons already installed, will complete the directional radio beacon system over the entire New York-Chicago route of National Air Transport, carrier of air mail and express.

No. 9. T. planes operating from Sleveland to New York, have been flown-for some time with the aid of department of commerce directional beacons and the 36 ships of the N. A. T. fleet as being equipped with the necessary receiving apparatus.

There will be no directional beacon station at Chicago. Planes westbound from Cleveland will follow the west heard by the pilot. In event of bad weather this will give him his position and shortly thereafter, the marker beacon at the Chicago Municipal Airport will be heard through his receivers and he will know that he is approaching his destination.

The use of the marker beacons on the Chicago end of the Eastern Division is made necessary by the fact that the radio directional beam cannot be bent around the curve in the course, caused by the lower end of Lake Michigan.

Department of Commerce radio engineers are also installing a directional beacon station at Sterling, Ill., as a continuance of the guilding system west of Chicago.


