## SUPERVISORS MEET MONDAY; ARE IRKED

### Perturbed Because of Purchases Made Without Authority; Face Problems

Irked because purchases have been made, and assessed to various departments without any notice to them, members of the purchasing committee of the board of supervisors on Monday planned to hold several conferences and if necessary carry their grievances to the floor of the county board chambers.

Along the same line it is understood that the old proposition of a regular purchasing agent might be considered.

Some of the supervisors were a trifle "hot under the collar" because they came to audit their accounts and found articles there that they had not authorized, says the Waukegan Sun.

### Have Hospital Problem

Supervisor David Van Patten, of Newport township, planned to bring up his request for several remodeling jobs at the county hospital tomorrow. He believes that from \$10,000 to \$20,000 will be needed to put the buildings in repair.

### Ask More Insurance

The insurance committee, composed of Supervisors Berry, McCann and Stanton, have requested increases of insurance at the court house, county hospital and county farm. They are \$40,000 more on courthouse equipment. Only \$10,000 is carried there now. At the hospital they ask an increase of \$95,000, while \$91,800 is carried now. At the county farm they have suggested \$20,000 more as an addition has been built there. No increase is asked for the Detention home on which \$12,500 is carried.

### Reports Are Made

The report of the state highway department that it would build roads asked for under the refund as soon as the refund is available was read and accepted.

Probate Clerk John R. Bullock reported that his balance to the treasury for the quarter was \$2,909 and Sheriff Lawrence Doolittle reported excess earnings of \$2,236.

The chairman, James O'Connor, of Deerfield, was authorized to appoint delegates to the state convention of supervisors that is to be held in Ottawa in August.
