

Hold Chicago Man in Death of Woman

M. Olzewski, alleged Chicago hit and run driver and traffic cutting motorists, last night was held responsible for the death of Mrs. C. O. Furbeck, of Wadhams Grove, by a coroner's jury in Cook county and was placed under arrest on manslaughter charges by Deputy Sheriff John De-Schmidt at the direction of State's Attorney A. V. Smith.

The coroner's probe was held at Wheeling last week, where Mrs. Furbeck-died after the sedan in which she had been riding was struck and forced into the ditch by Olzewski on Route 21 near Lake Villa.

Recommended Held

The jury recommended that Olzewski be held to the grand jury on manslaughter charges after hearing the testimony of Jens K. Doe, 2117 Bissell avenue, Chicago, and owner and driver of the sedan in which Mrs. Furbeck was fatally hurt and her husband critically injured.

Reach Agreement on Old Palatine Railway; Property to Be Sold

After years of bickering a tentative agreement was reached last week before Circuit Judge Claire C. Edwards, sitting as a refree in the interest of the defunct Palatine, Lake Zurich & Wauconda railroad, that will ultimately result in a sale of the property, it was learned.

Representatives of bondholders, who own 85 per cent of the stock; and three representatives of 95 per cent of the other 15 per cent of stock, ended the session in perfect harmony and consented to steps that would lead to clearing the title of the railroad that has been so badly clouded that sales could not be considered.

From what could be learned it is the intention of the purchasers to "junk" the property as far as railroad purposes go.

According to the agreements permission will be given to amend the suit now pending and confirm the appointment of the receiver and his acts in office.

Agreement to sell a certain part to the Methodist church at Wauconda for a site also is included.

In addition authorization to settle the difficulty with Wauconda Golf club was made.
