

ANNUAL APPROPRIATION ORDINANCE  
AN ORDINANCE Making Appropriations for  
Corporate Purposes for the Fiscal Year  
From June 1, 1929, to May 31, 1930.

BE IT ORDAINED By the Board of Com-  
missioners of the Highland Park East Park  
District, County of Lake and State of Illi-  
nois—

SECTION 1: That the following sums,  
or as much thereof as may be authorized by  
law, be and the same are hereby appro-  
priated for corporate purposes for the  
fiscal year commencing June 1, 1929, and  
ending May 31, 1930.

Table listing miscellaneous expenses including stationery, stamps, insurance, publishing, annual audit, engineering, and office equipment.

BONDED INDEBTEDNESS

Table listing expenses for bonded indebtedness including payment of maturing bonds and interest on bonded indebtedness.

LOCAL IMPROVEMENTS  
To meet Expenses of the  
Board of Local Im-  
provements

Table listing expenses for local improvements including publication & advertising, attorneys fees, cost of spreading assessments, fees of commissioners, court costs, engineering and surveyors services, witness fees, and expenses of litigation.

PUBLIC BENEFITS  
For payment of public benefits  
assessed or to be assessed in  
special assessment proceedings  
against the Park District as  
its share of the cost of local  
improvements.

Table listing public benefits including principal and interest thereon.

ACQUISITION OF PARK SITES AND PARK  
PROPERTY  
For the purchase of Park Sites  
and Property

Table listing acquisition of park sites and park property.

LEGAL EXPENSES AND EXPENSE OF  
LITIGATION

Table listing legal expenses and expense of litigation including special counsel fees, court costs, witness fees, miscellaneous expense of litigation, and miscellaneous legal expense.

any item or items of any general expense ap-  
propriation made by this ordinance may be ex-  
pended in making up any deficiency in any  
appropriation and for the same general pur-  
pose or in a like appropriation made by this  
ordinance.

SECTION 3. All ordinances or parts of  
ordinances in conflict herewith shall be and  
the same are hereby repealed.

SECTION 4. This ordinance shall be in  
full force and effect from and after its pas-  
sage, approval and publication.
