PLAN MOTOR COACH LINES ALONG SHORE

One to Traverse Sheridan Road, According to Petition to Commerce Body

Plans for the installation of two more motor coach lines along the North Shore, one to traverse Sheridan road from Chicago to Winthrop Harbor and possibly beyond and the other to run from Evanston to Libertyville, via Dempster street and Milwaukee road, became known last week through the filing of an application for establishment of such lines by the Chicago North Shore and Milwaukee railroad with the Illinois Commerce commission.

Filing of the petition by this railroad caused some surprise among members of the commission as it was generally understood that the railroad company had disposed of its motor coach lines to the Metropolitan Motor Coach company.

Officials of the railroad company were not prepared to explain the intentions of the company, at the time, says the Waukegan Sun, as the matter is being handled by its legal department, but it is considered likely. that the corporation intends to establish the lines and then transfer them to the Metropolitan coach company which, like the North Shore railroad, is a subsidiary of the Insull interests.

The petitions of the North Shore railroad asked for certificates of convenience and necessity provide for the following lines:

From the city of Chicago to the state line of Wisconsin, passing through Evanston, Wilmette, Kenilworth, Winnetka, Glencoe, Highland Park, Lake Forest, Lake Bluff, North Chicago, Waukegan, Zion and Winthrop Harbor.

Also from the city of Chicago to the city of Evanston and thence west on Main street to Lincoln avenue and Dempster street thence west to Milwaukee avenue and then north to Libertyville.

A third line which will proceed from Chicago to Evanston, thence west on Waukegan road and then north to Glenview is also provided for in the petition. The route of this line out of Evanston is not stated.

Three Lines to Evanston Under the plan the railroad will operate three motor coach lines into and out of the city of Evanston.

In all cases the petition provides for motor coach lines for the carrying of both passengers and baggage.

It is also pointed out that in each case the proposed motor coach lines parallel the lines of the North Shore railroad company but in the case of Sheridan road routing it is considered likely that the company seeks to operate busses on this highway because of its attractiveness and probably because of the possibility of obtaining many passengers for short hauls through the residential sections of the North Shore communities.

### HOLD HIGHWOOD MAN IN DEATH OF YOUTH

Joe Vole under Bond as Result of Fatal Injury to Brooklyn Hitch-Hiker

John Madden, 18 years old, of 222 56th street, Brooklyn, N. Y., was fatally injured Sunday afternoon as he was walking along the road on Prairie avenue in Highland Park.

Madden and Peter Mathews, aged 40, of 715 Greenridge street, New York City, were hitch-hiking their way through the country. They were walking west with an auto coming up to them from the rear when Joseph Vole of 219 Llewellyn avenue, Highwood, driving his father's Ford roadster, passed the other car and crashed into Madden, according to the report made to the police.

The youth was unconscious when he was picked up and had suffered a skull fracture, a broken leg and his arm and hand were badly cut. He died 12 hours later in the Highland Park hospital, where he was taken by Vale, and a telegram, sent to his mother failed to reach her until after the boy had died. Later she telephoned Chief of Police Moroney she would come to Highland Park, arriving Tuesday.

Mathews had his leg injured but not seriously.

Vole was arrested and charged with accoult with a deadly weapon. He was heard before Judge Walter Bartlett Monday afternoon and released under \$5,000 bond.

Upon his victim's death, a warrant charging Vole with manslaughter was issued.

An inquest was set for Tuesday morning, but was later postponed untill late Tuesday afternoon.

Verdict at Inquest The verdict was in accord with the circumstances, and the jury recommended that Vole be held to the Grand . -
