

#### Big Band Contest at Chicago World's Fair

Frederick A. Stock, conductor of the Chicago Symphony orchestra, will be one of the judges in the band concert contest which will decide just what musical organization will be given the right to call itself the Chicago World's Fair Symphony band, it was announced today.

It is planned to stage a series of 45 concerts in the various public parks of the city during July and August and to award the official title to the winning band some time in September. The first concert, according to the present plan, will be staged in The Daily News Plaza on July 10.

Walter A. Strong, publisher of The Daily News, has agreed to pay for five of the concerts, which will cost approximately \$1,000 each. The other concerts will be paid for by popular funds. All of the money raised will be paid to the musicians who participate in the various concerts.

In the concert ensemble will be musicians from the Civic Opera, the Chicago Symphony orchestra, the Little Symphony, the Chicago theater, the American Opera company and others who have been with Sousa, Arthur Pryor, Creatore, Ferullo, Conway, Armin Hand, Thavieu and other famous band conductors.

Lake County, Illinois, on Monday, 'the 29th day of July, 1929, at 7:45 o'clock P. M., at which time the bids will be opened and con-

All bids shall be made for cash and shall be accompanied by a certified check for Ten Per Cent (10%) of the amount of said bid. All bids shall be sealed and deposited with the City Clerk for presentation to the Council at said meeting.

Said described property will be sold to the highest and best bidder therefor for cash. Bids will be received either for the house

and garage together or for the house and garage as separate units.

Bids shall be accepted by a three-fourths vote of the members of the Council of the City of Highland Park.

Said ordinance provides that the Council may, by a majority vote, reject any and all hids, and it may adjourn consideration of said bids to the next regular meeting of the said Council. Said ordinance also provides that, in the event of the acceptance by the Council of the bid or bids for said property, the Mayor and City Clerk are directed to execute and deliver to the purchaser a bill of sale under the seal of the City of Highland Park embodying the terms and conditions of said ordinance set forth.

Said ordinance so passed on Monday, June 24. 1929, is on file in the office of the City Clerk in the City Hall and is open to public inspection.

#### CULINARY HINTS

A very delicious, as well as attractive, quick bread, is made with homemade candied orange peel. In making the candied peel, do not cook the syrup down so that it is absorbed, but leave enough of the syrup to keep the peel moist. A little of the syrup is used also in the bread. .

This may also be used as candied orange peel by draining, allowing to dry a little and rolling in granulated sugar. Peel may also be chopped fine and used for a sweet sandwich and a little of it is a tasty addition to a fruit salad.

#### Orange Bread

2 cups flour.

4 teaspoons baking powder.

½ teaspoon salt.

3 tablespoons sugar.

2 tablespoons shortening.

egg.

1 cup milk.

2 tablespoons syrup from candied

½ cup candied orange peel. Mix as for any quick bread, leaving the orange peel in strips and adding it last. Let stand in bread pan

then bake from 50 minutes to one

hour at 350 degrees. Candied Orange Peel Peel the oranges carefully so that

20 minutes before placing in oven,

the peel may be cut in long strips. Trim off the white inside membrane and cut the yellow peel in fine strips with scissors.

Cover with cold, salted water and let stand over night-not too much salt, but enough so that you can taste it. In the morning drain and cover with fresh cold water. Let stand about an hour, drain and cover with more fresh water. Repeat this two or three times.

Drain, cover with boiling water and cook until the peel is tender, then drain again. Make a syrup to cover, using 1 cup of granulated sugar to each 1/2 cup of water, cook and peel in this syrup until sweetened and transparent-about five minutes. Keep in a fruit jar ready to use.
