NUMEROUS CHANGES IN STATE FISH LAW

Digest of Alterations in Game Statute Given; Things Prohibited

If you are not acquainted with the new fish and game laws which went into effect July 1, and those who are not had better beware of the warden, as enforcement of the new rules is strict. The new laws were compiled by the house committee on conservation of fish and game working in harmony with the department of conservation and considering rules laid down under the migratory bird treaty. Under the law the minimum size of bass 10 inches, while on trout the minimum is 7 inches and on pickerel, pike or pike perch, 12 inches.

Other requirements of the law are: Catching of trout (except lake trout) by other means than hook and line prohibited. Season, April 16 to August 31.

Twenty-five per day limit in crap- Sheriff Doolittle stated that he pies, perch, sunfish, goggle eye and blue gill.

Minimum size for trout, 7 inches. Minimum size for pickerel and pike, or pike perch 12 inches.

New hunting regulations are: Closed season on wood ducks and carriages. elders until Sept. 1, 1931.

Maximum bag of brants and geese reduced from eight to four.

Hunting of migratory birds from elevated perch more than 10 feet from ground prohibited.

Foxes omitted from list of furbearing animals in section regulating hunting and trapping season.

Use of fireams in killing muskrats prohibited. Prohibit setting of traps within 10 feet of their houses, or in water within 10 feet of any shore line.

Devices Prohibited

Use of mechanical devices for frightening of animals from their holes and hiding places prohibited. Deer season-closed until 1930.

Persons who trap required to visit traps once every 24 hours.

Fee for nonresident hunting license increased from \$10 to \$15.

Monthly sworn statement to department of conservation required of all fur buyers, wholesale and retail.

Fee of 10 cents required from trappers for each hide of fur bearing animal: and from commercial breeders of wild game to each bird or animal or dozen of eggs or fraction thereof sold.
