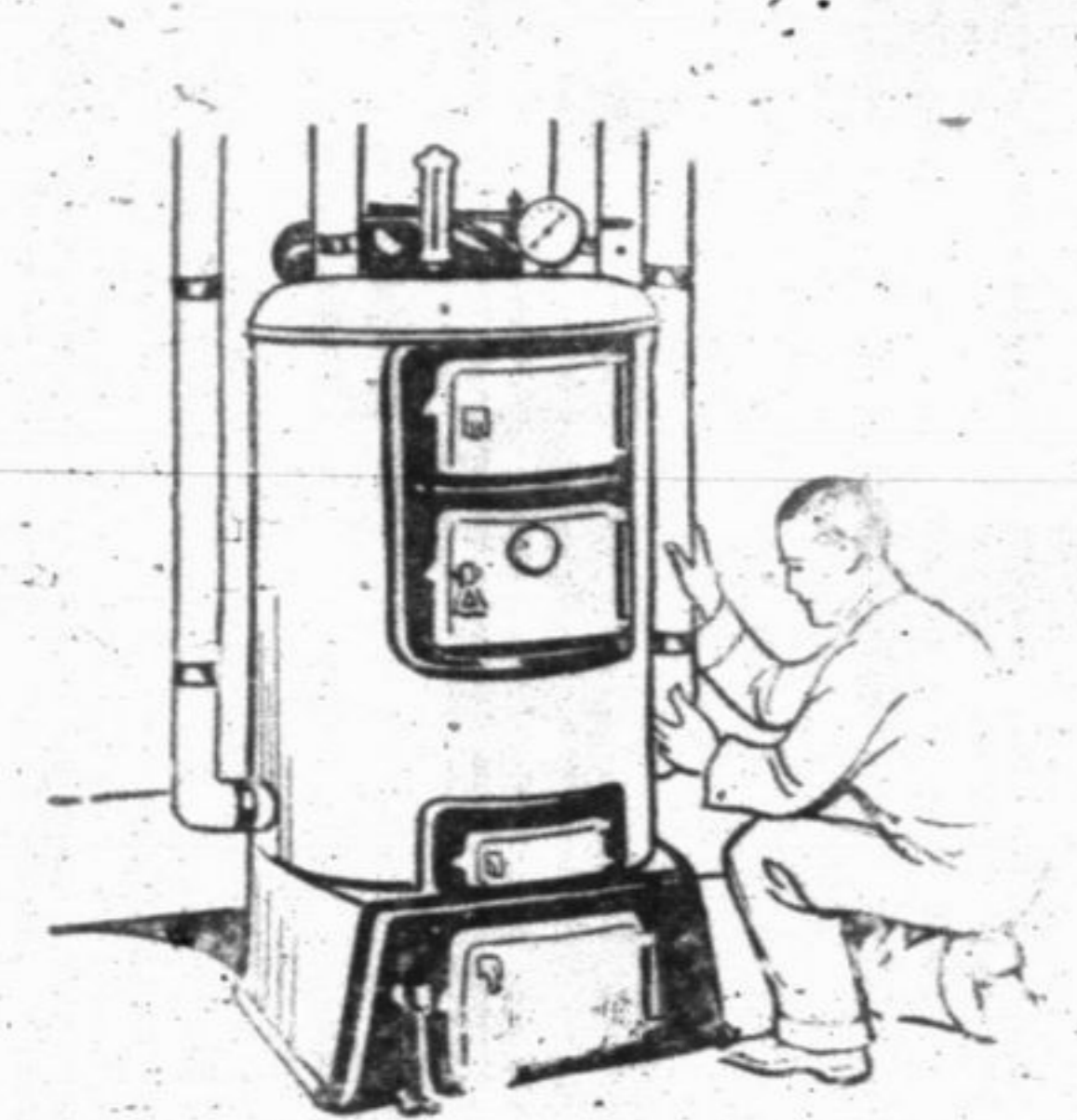

### Zion Gets Large Sum in State Road Refund

Under the statutes of the state of Illinois, all cities that have constructed hard surfaced (concrete) roads which connect state highways are entitled to receive from the state an amount, in the way of a refund, equal to the cost of constructing an 18-foot paving for the same distance. Under this law the city of Zion made application some time ago for a refund for the cost of construction of the paving on Elijah avenue between Shiloh boulevard and Twenty-ninth street, connecting state highway No. 42, known as Sheridan road, every cent of which was originally paid by Zion property owners.

The State Highway Department has estimated the cost of constructing an 18-foot pavement between these points, and the refund to the city of Zion has been fixed accordingly, at \$144,039.18.

This amount will be distributed by City Treasurer Armstrong to the present owners of property which was assessed for said improvement. It is estimated that the refund will be approximately 15 per cent of the assessment for the cost of constructing the improvement as made by the city.

### NOTICE OF SALE OF PUBLIC PROPERTY

Bids on the sale of said property for cash will be received and considered by the Council of the said City of Highland Park at the regular meeting of the Council to be held in the City Hall of the City of Highland Park, Lake County, Illinois, on Monday, the 9th day of September, 1929, at 7:45 o'clock P.M., at which time the bids will be opened and considered.

All bids shall be made for cash and shall be accompanied by a certified check for Ten Per Cent (10%) of the amount of said bid.

All bids shall be sealed and deposited with the City Clerk for presentation to the Council of said meeting.

Said described property will be sold to the highest and best bidder therefor for cash.

Bids shall be accepted by a three-fourths vote of the members of the Council of the City of Highland Park.

Said ordinance provides that the Council may, by a majority vote, reject any and all bids, and it may adjourn consideration of said bids to the next regular meeting of the said Council. Said ordinance also provides that, in the event of the acceptance by the Council of the bid or bids for said property, the Mayor and City Clerk are directed to execute and deliver to the purchaser a bill of sale under the seal of the City of Highland Park embodying the terms and conditions of said ordinance set forth.

Said ordinance so passed on Monday, June 24, 1929, is on file in the office of the City Clerk in the City Hall and is open to public inspection.
