Monday, the 16th day of September, A.D. 1929, for the furnishing of all tools, labor and materials necessary to perform the work of installing a garbage incinerator consisting of one single unit of forty (40) ton capacity in twenty (20) hours with building and stack of suitable size so that a second forty (40) ton unit can be installed later without interruption of service to the present plant, including entrance and exit ramps, toilet facilities, necessary electric lighting and all other equipment necessary for the successful operation of said plant.
