

EXPERT DISCUSSES PLANS FOR LIBRARY

Cincinnati Librarian and Authority on Subject, Guest of Local Board

Chalmers Hadley, librarian of the Cincinnati Public Library, was the guest last Friday afternoon and evening, of the Highland Park Public Library board, and the regular monthly meeting on that evening was given over to a discussion of the proposed new library building for the city.

Mr. Hadley was some years ago executive secretary of the American Library association at the national headquarters in Chicago, from which place he went to Denver, Colorado as librarian for 13 years. His book on "Library Buildings," which was published a few years ago, proclaimed him an authority on public library architecture, and he is today sought throughout the United States in an advisory capacity.

Gives Expert Advice

In planning a new library building, not only the need of the present day must be met, but it should as far as possible be adjustable to the conditions 25 or 30 years hence. Each community differs also and each library building and contents must become its community, Mr. Hadley explained.

He emphasized the necessity of placing a public building with constant use in a position of easy accessibility, close to the sidewalk and without ascending steps; the use of that side of the building with light and sun for the children's room; and the books within easy reach of borrowers and assistants. The present need of a building which may be administered with the greatest ease and efficiency by a small staff is a present necessity, but the rapid growth of library with the city will soon mean a larger staff and greater book capacity.

Will Inspect Plans

As the plans for the new building develop in detail they will be sent to Mr. Hadley for closer inspection and to others who have been suggested as experts in a particular phase of library architecture.

Mr. Hadley began his work as a leader in civic betterment as a newspaper man in Philadelphia, and his years of library experience combined with great charm as a speaker brought renewed interest and enthusiasm to the library workers of the city.

City Council Session Brief Monday Evening

The session of the city council Monday evening was a very brief one, only one item of business coming up for consideration, in the opening of bids for the sale of a strip of land off the city yard at Blodgett, described as the southerly 37.243 feet of lot 1, Mooney's commercial subdivision, as measured on the easterly line of McCraren road.

One bid was received in which Alexander J. Mooney offered \$600 for the strip. On motion of Commissioner Zimmer the bid was placed on file in the mayor's office for public inspection. Action thereon will be taken later. The meeting then adjourned.

MRS. McCORMICK IN RACE FOR SENATOR

Formal Announcement of Her Candidacy Issued Monday; Other Possibilities

Announcements of the decision of Mrs. Ruth Hanna McCormick to make the race for the Republican nomination for senator for Illinois against Senator Charles S. Deneen and such other candidates as may appear in the primary was received in Lake county Monday. The announcements were accompanied by letters signed by Mrs. McCormick authorizing the formal announcement in all newspapers of her candidacy.

This formal announcement was made from her home, Rock River Farms, at Byron, Ill. The statement, which is short and direct, presages what her managers declare will be a "bunkless" campaign on the part of the candidate, who is now a congressman at large from Illinois. It is as follows:

Formal Announcement

"I am a candidate for the Republican nomination for the office of United States Senator from Illinois at the primary election, April 8, 1930.

"Obviously, a candidate runs for office because he wants the office. But our system of choosing United States Senators wisely provides an opportunity for the voters of each party to examine the qualifications of all candidates before the party tickets are submitted to the people for election in the following November. In the campaign which I shall soon start I propose to speak to as many voters and visit as many of the communities of Illinois as my duties in the House of Representatives will permit. I shall then discuss fully those facts which may be held to affect my own qualifications for the Senatorship and those national and international issues on which I will be called upon to vote if elected to the Senate.

"I appreciate deeply the offers of support which have come to me, many of them long in advance of my decision to seek the Senatorship. Those friends and all other citizens are entitled now to my assurance, unqualifiedly given, that my candidacy is free from any direct or indirect obligation except only the fundamental obligation of integrity in public service."

Resume Standard Time Next Sunday Morning

The change back to standard time from the daylight saving schedule will be made at 2 o'clock next Sunday morning, Sept. 29, and Highland Park and other cities which have been operating on the summer time system will regain the hour lost last spring when the clocks were set ahead. This year daylight saving extended one week longer than usual, as September has five Sundays in 1929, and in most towns ordinance call for a change back to standard time on the last Sunday in this month.

Those who must rise early to go to their work will welcome the change, as already many of them find it necessary to begin the day before daylight.
