#### Plan to Reorganize Conservancy District

The petition in the Chain of Lakes conservancy district case was dismissed in County court last week due to the withdrawal of names from the original petition, taking away from the commissioners their jurisdiction in the matter. Attorney Geo. F. Hurley of Chicago represented the petitioners and the firm of Runyard and Behanna acted for the objectors.

The district will re-organize and be in operation again by July, 1930, according to J. C. James, Lake county representative on the original Chain of Lakes conservancy board. Twenty-five men, representing all the lakes in the chain, will compose the new board.

The re-organizing is to be done with the idea of taking in the Fox river as far as the McHenry dam instead of going only to the present limit.
