Huge Quantity of Ice Cream Used in Chicago

It takes more than three and a half gallons of ice cream annually to satisfy the demands of Chicago residents, according to the Chicago Association of Commerce. A study of the steady growth in popularity of the frozen delicacies shows that little brother's daily ice cream cone and the vari-colored concoctions like tutti fruiti and pistachio that mother serves for dessert are combining to give the Illinois metropolis an annual ice cream business topping better than 12,750,000 gallons.

Packed in five-gallon cans, ice cream in sufficient quantities to surround the city with a wall six feet high is consumed in Chicago yearly. Placed end to end, these cans would extend 1,100 miles beyond Denver, according to the Association of Commerce industrial experts. Eighteen manufacturing plants, covering 300 ice cream routes daily, supply the demand.


