### Approve Visiting Nurse Proposition in Deerfield

The following letter was sent to Dr. W. B. Metcalf following a speaction on the hiring of a nurse was taken:

> Deerfield, Illinois October 20, 1929

Dr. Walter B. Metcalf Deerfield, Illinois Dear Sir:

"A special meeting of the Village Council was held Monday, October 26. At this meeting, the question of the need of a village nurse was brought up. The hiring of the nurse was approved by the council and you are hereby advised that you are appointed as associate commissioner she began work.' "Your special functions, however, are to look after the health and sanitary conditions of the two schools and the nurse is to report to you and be under your supervision.

Mr. William W. Geary President, Village of Deerfield Dear Sir:

"Your letter of October 30, 1929, tendering me the appointment to the position of Associate Commissioner of Health, received.

"I am deeply mindful of the responsibility imposed in accepting this appointment. However, the task is one I will not put aside. I accept it in a spirit of service, confident in the hope that the parents of Deerfield will have as keen a realization of their responsibility. Let us not forget that the entire child goes to school, body, mind, soul.

This is a community proposition. Yours very truly, Dr. Walter B. Metcalf."

A group of interested and public spirited mothers of children of Wilmot and Deerfield schools met at the home of Mrs. S. M., Goder early in October and discussed the apparent and urgent need of a school nurse. Prior to the meeting Mrs. Gooder had consulted Dr. C. J. Davis, commissioner of health, who was unable to be at the meeting, but sent the fololwing letter, which was read at meeting and also at the Village Board meeting when a committee from the group brought the matter to the attention of the board.

> Highland Park Hospital October 7, 1929

My dear Mrs. Gooder:

"Regarding our recent conversation during which the subject of medical inspection of school children and the need of a school nurse for the Deerfield and the Wilmot schools was considered; would like to add to what I stated at that time regarding the latter; the need of a school nurse. I have given the matter much consideration since then and I cannot conceive of a single reason why it would not be of the greatest benefit to the community.

"We haven't forgotten our epidemic of scarlet fever of last year with the loss of time in school to the children and the inconvenience to the families during the necessary quar-

antine. A school nurse would be great factor in the matter of controlling all contagious disease; by regular examinations she would recognize and recommend to the parents for cial meeting of Village Council when correction, the more common physical defects schol children are subject to. ### Col. A. V. Smith May Run for Congress; Is Considering It


