Dr. Stewart has been rector of St Luke's church of Evanston, Illinois for 25 years. Prominent Educator

Dr. Stewart graduated from the Northwestern university in 1902 and later became the first president and organizer of Northwestern Alumni association and founder and first president of the Chicago club for Northwestern men. In 1915 he received the degree of Doctor of Letters from Kenyon college, Gambier, Ohio, and in 1917 the dgree of D.D., from his Alma Mater.
