

### Father Magner's Church at Evanston Is Robbed

When the Rev. J. F. Magner, pastor of St. Mary's church at Lake street and Oak avenue, Evanston, opened the church to celebrate six o'clock mass, one morning last week, discovered that vandals had broken in during the night, desecrating the sanctuary and stealing the contents of three alms boxes.

The thieves had entered through an unlocked basement window, afterwards found open. They stopped first in the sacristy, pulled vestments from

the wardrobes and altar linens from drawers, strewing them on the floor and trampling them. A hidden safe, containing jeweled chalices, monstrances and other sacred articles had been overlooked.

Highwood residents, in particular, regret the committing of the theft, since Rev. Magner for years headed the Catholic church at Highwood and left only seven months ago to take up his duties at the Evanston church. The Evanston police believe they have clues which may result in the arrest of the malicious thieves.
