

FINAL SPECIAL ASSESSMENT NOTICE, DEERFIELD SPECIAL ASSESSMENT, DOCKET NO. 75 IN THE COUNTY COURT OF LAKE COUNTY, ILLINOIS

NOTICE IS HEREBY GIVEN TO ALL PERSONS INTERESTED, That the Board of Local Improvements of the Village of Deerfield, Lake County, Illinois, has heretofore filed in the County Court of Lake County, Illinois, in the above entitled cause, its Certificate showing the cost of said improvement, including the cost of engineering services, the lawful expenses attending the same, and the cost of making and collecting the assessment therefor, and the amount estimated by the Board of Local Improvements to be required to pay the accruing interest on bonds or vouchers issued to anticipate the collection of the amount assessed for said improvement, and also stating that said improvement has been constructed in substantial conformity to the requirements of the original ordinance

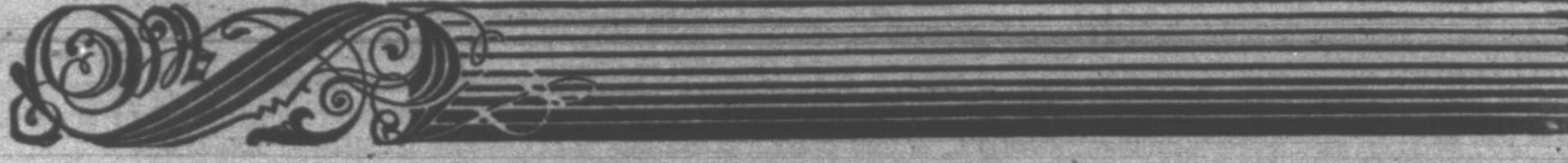

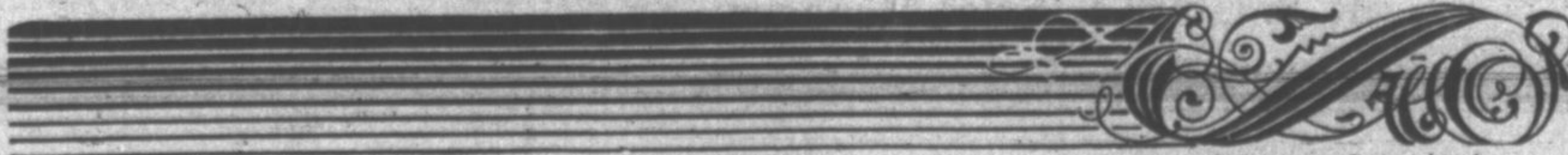
