

BRIEF NEWS ITEMS FROM LAKE COUNTY

Interesting Happenings About North Shore; Doings at County Seat

Mrs. William A. Fischer, of Lake Villa, passed away in the Victory Memorial hospital after an extended illness.

Ben Seigel, nephew of Sam Eisenberg, who was in Palestine at the time of the Jewish and Arabian rioting when a number of people were killed, has returned to Waukegan and is a guest of the Eisenbergs.

Inheritance tax in the estate of Dr. Edward Ford Gavin, of Waukegan, was approved at \$2,172 by County Judge P. L. Persons. The physician left an estate of \$74,582 with the bulk of it going to two brothers and a niece.

Mrs. Anna Diethorn, 62 years of age, passed away last week at her home in Libertyville. The decedent was born in Fremont township December 13, 1866. On January 24, 1892 she was married to Jacob Diethorn, who preceded her in death in 1911.

Oscar Hayden, of Fox Lake, was fined \$200 and costs and ordered out of the county after a hearing last week before Justice Harry Hoyt in which the man was charged with disorderly conduct on the complaint of Mrs. Ostrander.

States Attorney A. V. Smith has been advised that counsel for Isaac "Ike" Franklin, sentenced to serve 660 days in the state prison farm at Vandalia, will ask for a rehearing in the appellate court where the county court judgment recently was upheld as to the jail sentence.

Dr. Thomas P. Gallahue, county veterinarian, last week retained on a contract for another year by the county board of supervisors at his present salary of \$4,700. The appropriation for the department is \$6,000.

Lyman Wilmot, the son of Clerk of the Circuit court and Mrs. L. J. Wilmot, has been appointed a page in the House of Representatives at Washington, D. C., according to a telegram received from Congressman Carl H. Chindbloom who secured the appointment.

Value of building construction in the city of Waukegan during the present year will total about \$2,500,000, according to reports for the eleven months of the year as recorded by Walter Nibbelink, city building commissioner, and a prediction on the volume of construction during the remaining weeks of this month.
