DOG REFUGE AND 90 INMATES ARE BURNED

Fire of Possibly Incendiary Origin Destroys Orphans of Storm Kennels

Fire, suspected to have been of incendiary origin, early Tuesday morning destroyed the principal buildings of Irene Castle McLaughlin's straydog refuge, known as Orphans of the Storm, two miles west of Deerfield and resulted in the death of about 90 of the dogs housed in the kennels. The loss on the buildings is variously estimated up to \$10,000.

Fanned by a brisk wind the fire quickly destroyed the large Kennel building, the office of the institution, a hay barn and a cook house, while departments from Deerfield and Highland Park fought vainly to save them. The home of the caretaker, located but 25 feet from one of the kennels escaped damage.

The belief held by the caretaker, Thomas Webster, and his wife that the telephone wires at the place had been cut and that the fire broke out in at least two of the buildings at the same time caused attaches of the sheriffs office and Deerfield police to scent incendiarism in the fire.

Threats Reported Reports also received by the police state that Mrs. McLaughlin has been receiving threatening letters which informed her that if she did not abandone the establishment that it would be removed in another manner.

Webster and his wife were awakened early this morning by the crackling of flames. Two of the buildings were burning. Efforts to use the telephone to summon the Deerfield fire department failed and Mrs. Webster ran about two miles to the nearest available.

In the meantime her husband tried to rescue some of the degs which were trapped in the burning building. He succeeded in carrying but three of the animals out of the buildings. All had been overcome by smoke and heat and lived but a few minutes.
