

Drs. Page and Weil Form Partnership

Dr. Forrest H. Page, who has for two years maintained an office here, has formed an associateship with Dr. George L. Weil, formerly of Seattle, it was announced today.

Previously Dr. Page was at his Highland Park office only on alternate days—Mondays, Wednesdays, and Fridays—spending the other days at his loop office, 418 Lyon & Healy Building, Chicago. The new arrangement will permit him to give Highland Park a full-time daily service, as he or Dr. Weil will be in attendance here by appointment each day from 9:00 a.m. A greatly increased patronage necessitated the expansion.

The newly formed associateship will continue along the lines laid down by Doctor Page since opening here—viz., general osteopathic practice, specializing in diseases of the eye, ear, nose and throat; foot-corrective work; confinement cases; and conditions necessitating ultra-violet modern equipment for the care of these diseases, with several lamps especially designed for their use.

Thirteen Cases Slated for Grand Jury Hearing at March Term, Report

Thirteen cases involving 15 defendants are thus far slated for the inspection of the March grand jury which will convene in the courthouse on March 3.

The criminal case of the greatest interest is that of William Klarkowski, formerly deputy sheriff, who is now in the county jail charged with the murder of Douglas Steuber, a plumber, of 714 Massena avenue, Waukegan, during a drunken argument in the early morning of January 13. A bitter fight is anticipated in the prosecution of the charges, due to the fact that the plumber's union has taken an active hand in the case, retaining Attorney James Welch to sit in with the State's attorney during the trial.

The prosecution of Sebastian Gotter, charged with assault with a deadly weapon, will take a leading position on the criminal docket. Gotter was captured in Milwaukee by Sheriff Lawrence Doolittle at the end of December after having been a fugitive for a year following the shooting of Mr. and Mrs. August Hallman at their Fourth Lake estate where Gotter was employed as a caretaker.

Another murder indictment is possible in the case of John Dodarian of Waukegan who is in the county jail for the murder of Mamet Ali during a Turkish-Armenian political argument. Ali was fatally stabbed on the night of December 9, dying at the county hospital a week later.
