Mr. James R. Goetz was elected scout commissioner of the North Shore Area council for the year 1930 at the recent annual council meeting at New Trier high school.

**MEL MULLINS LOSES  
IN TRIBUNE TOURNEY**

Mel Mullins, our tough little battler from Deerfield-Shields, was forced out of the Chicago Tribune's Annual Golden Glove tourney last Thursday night by Kid Chiolero, of Sawyersville. Incidentally, Chiolero broke his thumb in a fight with William Copitano on the same night that he fought Mullins, and wasn't able to continue in the bouts the next night.

In the trials held at the Rainbow Fronton, Mel won over Howard Craft, of Grayslake, Illinois, on a foul in the third round. On the same night he whipped another adversary, decisively, and so earned the right to compete in the finals, held at the Coliseum, February 25, 26, 27, and 28.

He was entered in the 126-pound class and drew as his first opponent,

one Jack Jacobs. Jacobs was compelled to assume a horizontal pose before the first round was over. After a short period of rest, Mel encountered Kid Chiolero, who, after a hard struggle for three rounds, won over Mullins on points.

The sport writers of the Chicago Tribune described Mullins as a game little fighter and "almost as tough as his brother, Moe Mullins." Mel has been boxing for two years and is progressing rapidly under the tutorship of Ed Jacobson of Deerfield.

Mel was in the Golden Glove tourney last year but was put out in his first fight. But he is a good boxer and will undoubtedly do better next year.
