Such camps are indorsed widely by intelligent leaders of every political and religious faith throughout the country as a practical means of developing our youth in the wholesome surroundings of outdoor living.

Many Ways to Aid

"There are many definite ways that Legion posts may support the C. M. T. C. movement, as indicated by past experience. Virtually all Legion departments appoint a state C. M. T. C. officer who co-operates with the authorities in charge of the movement. County and post C. M. T. C. officers are then appointed by the Legion to effect a closer co-operation. Allotments of candidates are made to the individual Legion posts by the state 3-4 headquarters. The post proceeds to obtain this allotment of boys who will enjoy the benefit of the camps. Units of the Auxiliary have aided the Legion posts materially in supplying names of prospective candidates.

"Posts have then given send-off luncheons for candidates. Hostesses are often supplied for the camps through Legion or Legion auxiliary efforts. More athletic equipment is often provided by the Legion. One of the most important contributions of the Legion has been the formation of C. M. T. C. clubs that include all former trainees. These clubs pre-'serve the pleasant memories of the days spent in summer camps. Enlistment of the support of public schools, civic organizations, and industrial concerns, and the arousing public consciousness as to the merit of the training offered free in the C. M. T. C. have been important phases of Legion co-operation. ..

During the last three months the Lake County General hospital has operated for \$4,392 less than it did in the corresponding quarter a year ago according to a report submitted to the county board of supervisors last

The actual operating expense was \$18,781 against \$23,236 for the months of December, January and February a year ago.

The reduction has come through the printing of the names of all who receive aid at the hospital.
