**Supervisors Vote to  
Probe Soap Purchase  
Adopt Resolutions**

Supervisor Edward Mawman, Lake Bluff, who twice carried purchases of soap to the floor of the county board of supervisors, last week succeeded in having the board put through a series of four resolutions covering the \$1,950 purchase of soap at \$2 a gallon.

The supervisors not only halted at the last purchase made by the buildings and grounds committee composed of Supervisors William Obee, Highland Park; Charles Crapo, Waukegan, and Mawman but demanded that an accounting go back as far as 1923, which is the time the committee started purchasing from the same soap firm, says the Waukegan Sun.

The soap committee will be asked to make an accounting on discounts allowed between 1923 and 1930 and an accounting on soap drums over the same period. A \$5 deposit has to be made on drums containing the expensive liquid cleanser.

A third resolution ordered the purchasing committee to investigate soap prices.

A fourth resolution prevents the use of the 15 drum shipment now stored in the county building and the return of the drums taken to the county farm.
