From the slopes of sunny Italy come the inspirations for that youngest of the fine arts—the art of landscape gardening. And is the charm of these old world gardens compatible in the new world? Surely—for her may be found many situations

wherein the garden art of Italy may find opportunities for its best expression.

Here may be found the hillside property, which, under the helpful guidance of the landscape gardener, becomes a series of inviting terraces. Each an outdoor room capable of an endless variety of arrangements, yet all blending into the design and development of the entire home property so necessary to its best use and enjoyment.

Here the marble steps, ramps and

balustrades, so typical of old Italy, become flag-stone steps and garden paths, hedges of living green and walls of varied textures.

Nor need such a development be confined to sloping sites. The average small home property, with its limited area of level lawn, offers splendid opportunities for the orderly arrangement of plants and garden furniture, so typical of these gardens from other the sea.

Related to the house itself, in fact best connected directly with it, the

backyard of an age gone by becomes a modern outdoor living room. In such a room may the garden hobbyist indulge in her every fancy.

Of course you will want to enclose this area so that your outdoor hours may be enjoyed in privacy and seclusion. For this, trimmed hedges of close texture serve best. Welcome shade will be provided by overhanging trees; garden seats will bid you to rest and repose, and colorful flowering plants will provide all season pleasure. Then to complete the picture, a wall fountain, rill or pool, to catch and reflect the blue of the sky above.

Yes—a bit of old Italy may be yours to enjoy. Plan wisely, plant properly and tend it with care.

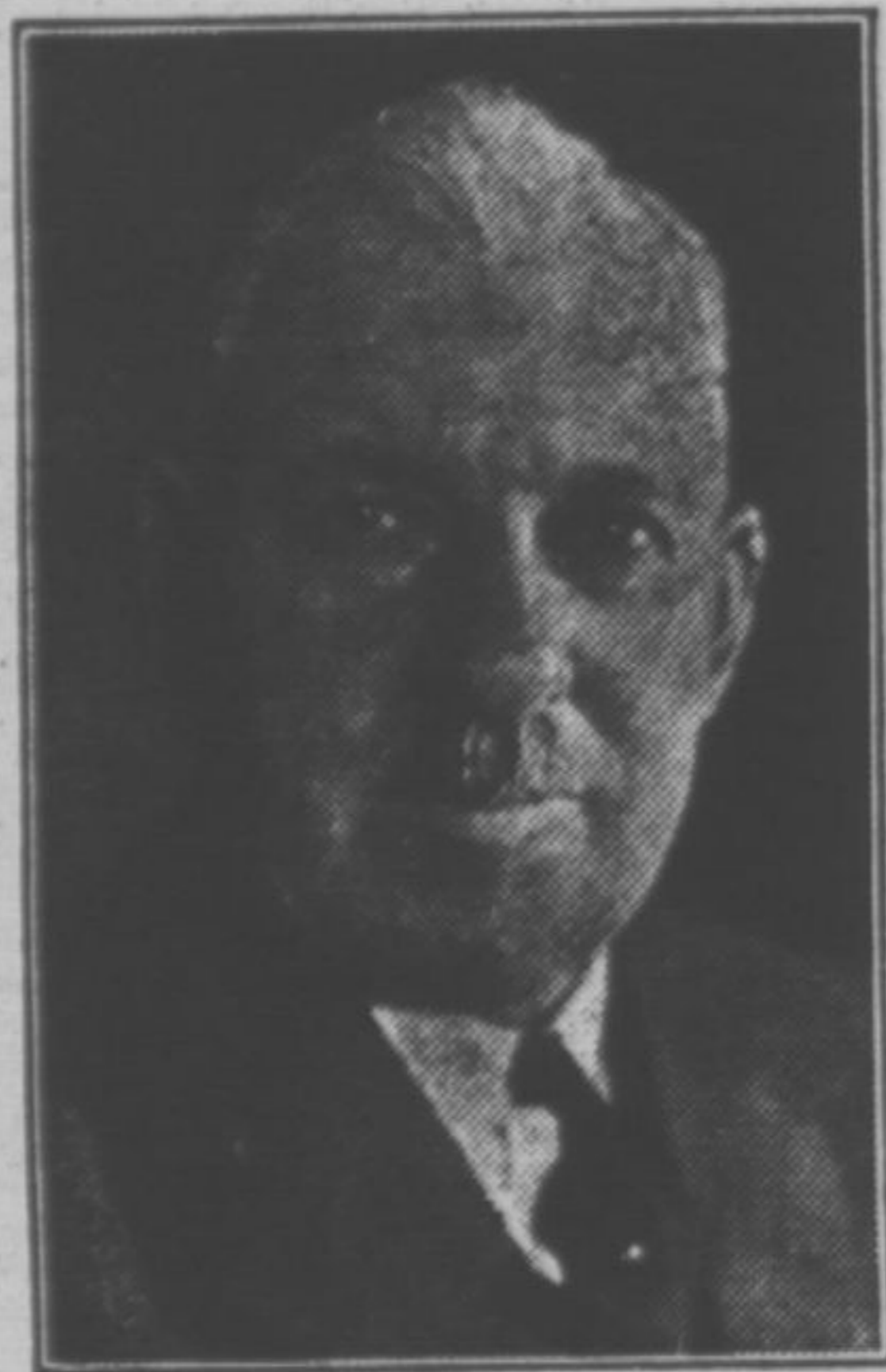
### Attend Trap Shooting Tourney in Chicago
