Snowstorm Does Much Damage in the County

With some half dozen summer cottages along the lake front at Zion in danger of being washed out into the lake, the Warren high school at Gurnee, and several other schools in the county, closed because of the storm, Wauconda snowed under with even sleighs stuck in the deep snow banks and motor traffic between Chicago and Milwaukee along the state highways completely paralyzed, Lake county spent the latter part of last week digging out from under a 43hour storm that left 19 inches of snow on the level and drifts from four to six feet over many of the highways.

Aside from cripple traffic, the worst damage along the north shore occurred at Zion where it was reported that monster breakers had worn away a 7-foot bluff at the beach and waves were pounding against a row of summer cottages belonging to Zion people. At least six of the cottages were threatened with being tossed out into the lake as water from five to six feet deep was swirling about the piles on which the cottages were built.

A thousand-foot stretch of sidewalk from the north limits of Zion to the refreshment pavilion on the lake front was completely washed away, Waukegan papers report.

Libertyville Board to Act on Annexation


