More Than 60 of Them in Illinois Seeking Election This Year

With more than 60 women candidates running for county offices, Illinois women are taking a significant part in the present primary battle, the Illinois League of Women Voters pointed out today, says a report from Springfield.

The most popular county office to which the women aspire is that of superintendent of schools. Approximately 25 women are running for this office. A close second in the esteem of women office seekers is the position of treasurer for which 17 women have announced their candidacy.

Among other offices for which women are seeking nominations are county judge, probate judge, commissioner, county clerk and probate clerk. There are women candidates in about half of the counties of the state.
