composed of Lake, McHenry and Boone counties, indications were that Richard J. Lyons of Mundelein was leading, with Lee McDonough of Waukegan second and William M. Carroll of Woodstock third. The bulk of the returns from McHenry county were not in when this report was made.

In Lake county Lyons received 32,464, McDonough, 22,608, and Carroll, 6,863. Mrs. Grace Bairstow of Waukegan, the only woman candidate for representative received in the entire district, with only partial returns from McHenry, a total of 6,924. Other candidates were lower.
