half inch balsam wool in the outside walls and 3 inches of thermo fill in the ceiling. Sisalkfart building paper is used under the heavy half inch red-wood shingles which form the outside wall covering.

The heating plant is installed with flat ducts in the basement, leaving the basement free from objectionable pipes. Due to the forced circulation in this heating plant, it has been possible to confine the plant to one little corner in the basement, leaving room for a large laundry and a very attractive recreation room, 13x20 feet, with a fireplace. The basement will always be dry because of proper water-proofing, adequate drainage around the footings, and large windows which will let in the sunshine and give good ventilation.

This house will be sold to the highest bidder. Sealed bids will be received by the Highland Park State bank as trustee. Bids will be opened May 16.

The house will be open daily for the public's inspection during the National campaign week of "Better Homes in America" April 27 to May 3, of which Mrs. Howard G. Chevrolet Wins Los Angeles Economy Run

Wm. H. Ruehl & Co., local Chevrolet dealers, received the following report of an economy run held in California:

A 6-cylinder Chevrolet coach driven by Mrs. Paul Lawrence of California, won first place in a 200-mile economy run for stock cars from Los Angeles to the Wrightwood Mountains February 21.

The Chevrolet was awarded first place in economy by setting a new record with an average of 36.71 ton miles per gallon, or in the usual method of measurement, averaged better than twenty miles to the gallon of gasoline.

In reporting the great economy run, the Los Angeles Evening Herald said, "Mrs. Lawrence's mark is an official record and she can justly wear the badge of the 'World's Woman Driver Economy Champion.'"

Simpson Signs Order Detaching Lake Forest from Deerfield-Shields

T. Arthur Simpson, county superintendent of schools on Saturday last signed an order which makes it possible for Lake Forest to go ahead with its plans of putting up its own high school, as soon as a board of education is elected. The order creates a separate high school district for Lake Forest freeing the town from the Deerfield-Shields township high school district.

The statute under which the new school district was formed specifies that the election of members to the board must be held within 30 days.
