#### Says Gangsters Plan Resort in Lake County Officials are Watchful

George "Bugs" Moran and Leo Mongoven, Chicago hoodlums who last year were driven out of the county by State's Attorney A. V. Smith after they launched a sensational campaign to establish beer and vice privileges in the Lake region by terrorizing resort keepers with machine guns, have once more turned their eye on Lake county and are planning to stage a come back, it was learned from a reliable source, says the Waukegan News-Sun, which continues:

Moran and Mongoven have been seen touring about the western part of the county several times of late making friendly calls on various resort keepers whom they regard as potential customers for their beer and alcohol. It is said they have leased a secluded farm handily located to facilitate delivery of their "products," on which they plan to locate a brewery. Moran and his bodyguard are known to have negotiated for the purchase of a piece of property near Antioch.

Both Moran and Mongoven are included in a list with 26 other Chicago hoodlums who yesterday were labelled "public enemies" by the Chicago crime commission with recommendation they be driven from the city. Consequently things are not going so good so Moran is determined to once more attempt to set-up rackets in this territory that will provide funds to which he has become accutomed.

It will be recalled that last summer Moran established headquarters at the Elizabeth Cassidy resort at Bluff Lake, which was subsequently raided numerous times by Contable George Stried and finally closed by injunction proceedings instituted by Col. Smith.






