franchisement of women by amendment to our constitution, the attorney general of the state gave it as his opinion that a legislative enactment would be required to make women eligible to fulfill this duty of citizenship, and the state legislature refused to pass such acts until more than eight years had elapsed. During these years Illinois citizens were denied the benefits incident to having the combined viewpoints of men and women expressed in the jury box. In both our state and nation it has been recognized that the ballot box should give opportunity for the expression of the viewpoints of all of our citizens of mature age, and it can scarcely be less desirable that the judicial system should recognize such differing viewpoints and take advantage of them.
