### ADOPT RESOLUTION HONOR OF EDWARDS

Retired Judge of Lake Co. Circuit Court Tendered Memorial; Text

A memorial to Attorney Claire C. Edwards, former judge of the circuit court, was read in the courtroom last week, with Judge Edward Shurtleff presiding, by Benjamin T. Miller, chairman of the Lake county bar association committee which prepared the resolution. The memorial was made a part of the record of the court. It read:

The Memorial

"The Lake County Bar Association, at its March meeting, learned with deep regret of the resignation of Hon. Claire C. Edwards as Judge of the Circuit Court for the Seventeenth Judicial District of the State of Illinois, effective April 1, 1930.

"Judge Edwards was appointed to the Circuit Court, September 28, 1914 to fill the vacancy caused by the death of Honorable Charles Whitney, and was elected without opposition in 1915, in 1921 and in 1927, thus serving as Circuit Judge for a period of 16 years.

"Judge Edwards' career on the. bench was distinguished by a high order of Judicial service. He possessed the rare combination of legal ability and judicial temperament. He was always courteous and considerate to the members of the bar, to court dignity, but not with austerity. He officials, to jurors and to litigants.

"He presided over his court with was always careful and considerate of the rights of others, and insistent that all parties and counsel should have a full and fair hearing in his court.

"His service on the bench did much to promote justice, give confidence to our courts, and elevate the legal profession. During all the years of his service he received the loyal support of the members of the Lake county bar. They respected him for his legal learning. They loved him for the friendly spirit and kindly helpfulness which he always extended to them, and for the fair and courteous treatment which they always received.

"Judge Edwards' decisions were generally regarded as just, and stood the tests of the higher courts, with fewer reversals than fall to the lot of the average judge.

"While we regret the retirement of Judge Edwards from the bench, we welcome him to the bar. The same qualities which made him a successful practicing lawyer. We, today extend to him our friendly greetings and our best wishes for continued success in his chosen profession."
