

DEERFIELD RALLIES; DOWNS PROVISO 6-5

Scoring four runs on three walks and singles by Segert, Maloney, and O'Connor, the league-leading Deerfield nine won its fourth straight league victory over Proviso, 6-5. The game was featured by Fred Drakeman's air-tight pitching. He allowed only seven hits and walked one man. Fred struck out three and threw out seven men.

The long drives of the game were supplied by Rehr and Crandall of Proviso who hit home runs under the fence in center. "Wallie" Dettman led off in the first inning with a triple to right center. He later scored on a sacrifice fly by Tom Rogan.

First Inning Proviso

Young was out Dettman to Segert. Drakeman tossed out Smith. Lekawitch singled down the third base line. Belline flied to Martin. No runs, one hit.

Deerfield

Dettman tripled to deep right center. O'Connor flied to short right and Dettman held third. Rogan hit a sacrifice to center, Dettman scoring after the catch. Martin fanned. One run, one hit.

Second Inning Proviso

Rehr hit a home run under the fence in left center. Haas grounded to short, but Rogan made a bad throw and Haas took second. Languth laid down a sacrifice bunt, Haas going to third. Drakeman struck out Crandall and Brown, and Haas died on third. One run, one hit.

Deerfield

Berube struck out, Belline dropped the ball, but threw the batter out at first. Smith misjudged Segert's high pop and he was safe at first. Maloney grounded to Crandall, Segert taking second. Bestor struck out, Belline again dropped the ball, but Bestor was tagged out. No runs, no hits.

Third Inning Proviso

Young singled past second base. Smith struck out. Berube made a circus catch of Lekawitch's low liner and Young was doubled off first. No runs, one hit.

Deerfield

Drakeman struck out. Dettman walked. O'Connor popped to Languth. Dettman was out stealing. No runs, no hits.

Fourth Inning Proviso

Drakeman tossed out Belline. Rehr's second hit was a single past second. Haas was called out for bunting foul on the third strike. Rehr stole second. Languth walked. Crandall hit a home run under the center field fence, scoring Rehr and Languth. Drakeman threw out Brown. Three runs, two hits.

Deerfield

Rogan singled to center. Martin flied to Haas. Rogan stole second and third. Berube hit to Crandall and Rogan was safe at home when Belline dropped the peg to the plate. Berube stole second. Segert flied to Rehr, and Berube held second. Maloney also flied to Rehr. One run, one hit.

Fifth Inning Proviso

Drakeman tossed out Young. Smith

slammed a single between first and second. Lekawitch forced Smith, Segert to Rogan. Lekawitch stole second and scored on Belline's double to left. Rehr grounded out to Rogan. One run, two hits.

Deerfield

Bestor fanned. Drakeman walked. Dettman forced Drakeman. O'Connor walked. Rogan flied to Lekawitch. No runs, no hits.

Sixth Inning Proviso

Haas flied to Bestor. Rogan tossed out Languth. Crandall flied to Maloney. No runs, no hits.

Deerfield

Martin was passed. Berube fanned. Segert singled to center and went to second when Martin was safe at third. Maloney singled to center, scoring Martin and putting Segert on third. Maloney took second on the play at home. Weihle replaced Brown on the mound for Proviso. Bestor walked. Haas replaced Weihle after six consecutive balls, and Baumgartner went to right field. Drakeman walked, and Segert was forced in. Dettman hit a high pop to Haas. O'Connor smashed a single through short, scoring Maloney and Bestor with the tying and winning runs. Ro-

gan struck out. Four runs, three hits.

Seventh Inning Proviso

Drakeman tossed out Brown and Young for his sixth and seventh assists. Castle batted for Smith and was out, Rogan to Segert, ending the game. No runs, no hits.

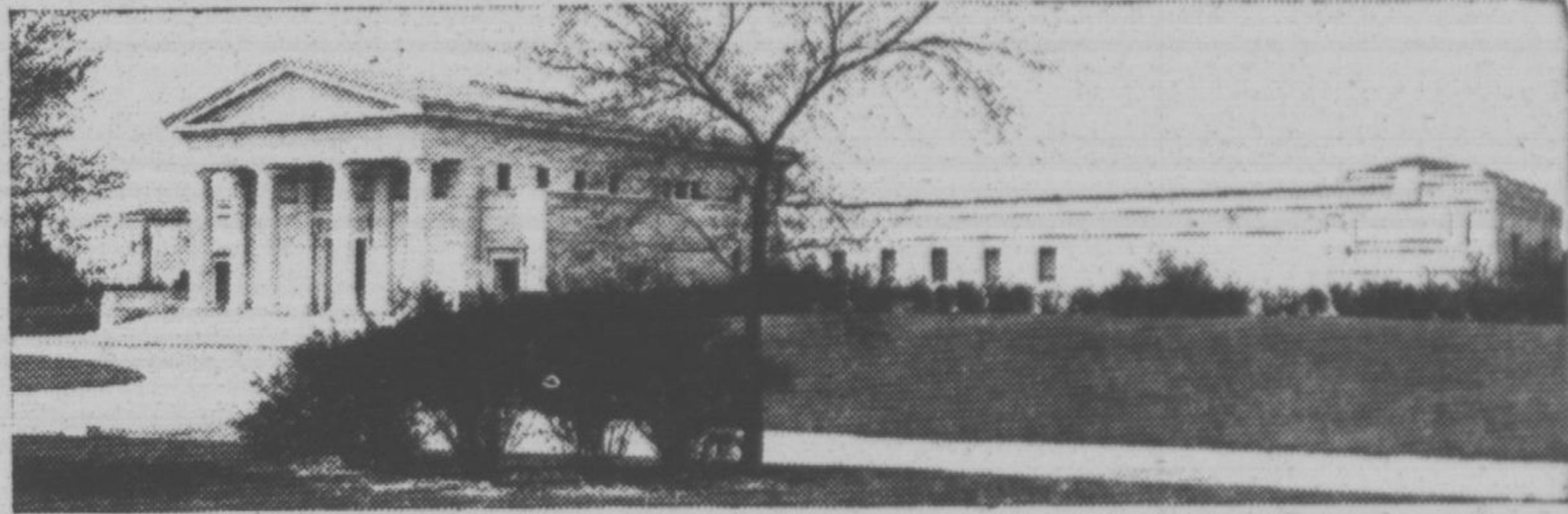
