ASSURES NEW OFFICE

Increase in Census Returns to Make Possible Election County Auditor

The general population increase through Lake county that indicates a resulting population in excess of 100,000, today assured Lake county a new office in the form of a county auditor, it was learned from County Clerk Lew A. Hendee.

Such an official could not be elected until November, 1932, under the law which provides for county auditors in counties of not less than 75,000 inhabitants.

The powers of such an official would be almost that of a purchasing agent. On any county purchases or contracts the auditor, under the law, would audit the claims and approve them before the county board of supervisors could give the final approval and allow the county clerk to pay the claim.

Salary Fixed by Board The salary of such an official would have to be set by the board of supervisors and an office in the county building provided.

The term of office would extend over a period of four years.

For years the county board has contracted with an outside auditor to come in at certain intervals of the year and audit books and show emoluments and expenditures.

Incidently any increase in population in the county would not effect salaries of other county officials, according to Mr. Hendee, who stated that the officials now received the maximum under the law.

Woman Defies Deputies For House; Is Finally Arrested; Hearing Set

An enraged woman, wanted on a contempt of court citation, last week fought deupty sheriffs by barricading herself in her home at Five Points.


