### REAPPOINT CHIEFS OF POLICE AND FIREMEN

submitted by the board some time ago.

The annual salary ordinance fixing compensation of city employes, etc., for the ensuing year was passed and will be published later. S. D. Morris was reappointed building inspector. The board recommended the passage of the Taylor avenue paving ordinance and this later was acted on by the council.

#### Several Petitions

The council granted the Chicago Children's Benefit league permission to hold a tag day here October 6. Petition asking that the Boy Scouts be allowed to use the new council chamber for Board of Review meetings each Friday evening, except during summer months, was held up for further investigation, as there are numerous applications for use of the room.

Petition of A. G. McPherson, Inc., for permit to install a gasoline pump on Park avenue where tanks are already installed was held for further consideration.

Several communications were received from the Ravinia Civic Commission. One of these asked co-operation in a plan to organize a mosquito abatement district. It was the opinion of the council that it was too late in the season to do anything this year, and as it was reported that one or two such districts had decided to disband owing to unsatisfactory results, ti was decided to investigate first, and the clerk was directed to write letters to neighboring district officials to ascertain the status of the matter in these districts.

Another of these communications was regarding sewage conditions at the foot of Cary avenue, and this was referred to Mayor Lewis, who has been conducting some correspondence in the matter.

Request that the city place street signs at intersections on Roger Williams avenue was referred to Commissioner Brown for investigation.

Communication regarding cutting of obnoxious weeds complained of in certain quarters in Ravinia was referred to the corporation counsel to see what could be done in the premises.

#### Referred to Counsel

A draft of an ordinance amending the building code in the matter of the size of fuel oil tanks inside was submitted by the building inspector and was referred to the corporation counsel, for report.

The matter of a report on zoning of a tract on Park avenue was discussed and the matter was laid over until later. Justice Schwery reported fines received amounting to \$202.
