

FIX SALARIES OF CITY OFFICIALS

Amounts to Be Paid Officers and Certain Employes During Fiscal Year

The annual salary ordinance for city officers and certain city employes, passed at the last meeting of the city council, is published in full in another column of this paper. The salaries, as given, are for the city's fiscal year, beginning May 1, 1930, and ending April 30, 1931, and according to the terms of the ordinance no city officer or employe mentioned in the ordinance is to receive any further compensation from the city during the term specified.

According to the terms of this ordinance the salaries of city officers and employes affected by its provisions are as follows:

City Hall Officials

The salary of the mayor is fixed at \$600 for the year and that of each commissioner at \$400. The salary of the city clerk is \$6,000. The compensation of the corporation counsel is placed at \$2,400, and that of the city treasurer at \$1,200. The city collector receives \$3,600.

The city marshal, or chief of police, receives, under this ordinance, \$3,300 for the next year, and police sergeants Nos. 1, 2 and 3 get \$2,220; police officers Nos. 2, 4, 5, 7 and 8 get \$2,160, and No. 9 \$2,100.

The salary of the foreman of streets and public improvements is fixed at \$1,500 for the year. The chief fire marshal gets \$3,300; the first assistant fire marshal in charge of the fire station during the day

WOMEN VOTERS HERE FAVOR JURY SERVICE

Members of League Quoted in Support of Bill to Give Them This Right

At the November election Illinois will decide by referendum if it desires to become the twenty-second state where women serve on juries.

A number of board members of the Highland Park League of Women Voters who were asked their opinion of women on juries, have responded as follows:

Local Members Favor It

Mrs. Robert Walker—"In all the states where women have the right of jury service, their work has been highly commended by judges and attorneys as conscientious, not emotional, efficient, and attentive. Women jurors have contributed to prompt and just verdicts, helping to obtain a better administration of justice. Public opinion is continually growing in favor of granting women this much needed right."

Mrs. Jay Glidden—"I am greatly in favor of women on juries. With the privilege of voting which women have, there should also be given the authority to serve on juries — this service being really only another duty of citizenship."

Mrs. Howell Murray — "Women benefit by citizenship; they should be glad to share in its responsibilities. Serving on a jury would be a liberalizing experience for most women, and
