Eight important motor bus lines in Lake county and the northern part of Cook county will be abandoned as the result of an order issued by the Illinois Commerce commission on Tuesday. Lack of business is the cause reported.

The lines to be abandoned are listed as follows:

First-Lake Bluff to Mundelein via Libertyville; Rockland road to Mundelein, also on Lake avenue from Rockland intersection to Diamond

Second-Glencoe to Wheeling via Sheridan and Dundee roads.

Third-Wilmette to Glenview via Ridge and Lake avenues to Waukegan road.

Fourth-Wilmette avenue station via Glenview road to Glenview.

Fifth-Deerfield via Deerfield road and Central avenue to Highland Park.

Sixth-Highland Park to Lake Zurich from Railroad station St. Johns avenue, Highland Park via St. Johns avenue, Vine avenue, St. Johns, Moraine road, Waukegan avenue, Highwood avenue, Highwood, North Shore station, High street, Prairie avenue, Prairie View road by High Moor station and through Half Day and Prairie View to Lake Zurich.

Seventh-Waukegan to Woodstock via Belvidere road No. 20 to Route 21 intersection in Grayslake from Route 20 and Longlake road intersection in Hainesville westerly to Rand road, in Volo from Route 20 and U. S. No. 12 in McHenry, westerly to Woodstock.

Eighth-Waukegan to Lake Villa from Milwaukee and Grand avenue in Gurnee westerly and northerly, on Grand and Fox Lake road to Route No. 59, intersection two miles west of Lake Villa.


