Proposals for the erection of the buildings are being asked in advertisements appearing in contractors' magazines and publications of general circulation. The bids are to be opened at the U.S. Veterans bureau building, Washington, D. C., at 11 clock on July 29.

The contracts on the project will he awarded on the understanding that they start the work of construction as early as possible in August.

Will Conform to Style

The style and type of the building will be the same as those which make' up the rest of the institution. Wall will be of brick, hollow tile and steel construction.

The awarding of this contract will bring the amount spent on the Veterans Bureau hospital to more than \$1,000,000 this year and indications are that the expenditures will reach a like amount for next year.


