

DISCUSSES ROUTE 42 CHANGES NORTHWARD

road at Laurel avenue, Highland Park.

From Laurel avenue the route would be north along First street to the intersection with Green Bay road and Vine avenue, thence north through Highwood, past military reservation at Fort Sheridan to Lake Forest, paralleling the North Western railroad on Western avenue to a point north of the business district.

From there automobiles could either pass under a viaduct back to Sheridan road or continue north to Waukegan on Green Bay road by detouring four blocks to the west. Green Bay road is now a 36-foot highway from Lake Bluff north to the state line.

Extend Road

The only new construction required by this plan would be extension of Green Bay road from Washington avenue, Highwood, past Fort Sheridan to the intersection with Western avenue in Lake Forest. The existing pavement in Highwood should be widened to 36 feet also, according to highway engineers.

Widen Highway

Widening of Green Bay road in Highland Park from Northmoor Country club north to Central avenue is also planned within the next few years. This step will be taken as part of the McCormick road extension program.

Green Bay road has been widened a width of 40 feet from the Lake county line north to the Northmoor club, where it meets the old pavements installed over 12 years ago.

State aid will be asked by the north shore towns in promoting the traffic relief program. Expressions favoring the project are said to have been obtained from highway officials.

A portion of the gasoline tax money will be asked to aid in promoting the new arterial highway, which it is hoped will be ready for traffic within two years.

D. A. R. Better Film Committee Reviews Current Movie Plays

The pictures listed for the coming week by some freak of chance, which is unfortunately unavoidable, have little appeal to those who are seeking the highest standard in movies.

True they are much discussed and might be said to be outstanding productions, but they have no especial value for the young and impressionable, and should be restricted more or less to mature audiences. The management has the interests of children at heart in his plans for the Saturday matinee, and is providing an "Our Gang" comedy, an animated cartoon, as well as the usual serial, and there is a Laurel and Hardy comedy listed for next week. Briefly, here are the comments on coming pictures:

"Caught Short," a farce-comedy dealing with the rise and fall of the stock market as it affects two boarding house keepers. Marie Dressler's inimitable acting is hilariously and

ludicrously funny. Amusing and harmless, but of little interest to children.

"Rough Romance," a good picture for a hot day, a movietone drama of the snowlands.

"Young Man of Manhattan," with Claudette Colbert and Charles Ruggles. Newspaper story glorifying the "gay life" with young married pair agreeing to be "broadminded" about each other's conduct. Good work by the principals cannot redeem the mess. Adults.

"The Divorcee," Norma Shearer's excellent acting seems wasted on a theme which deals with life presented as a continuous party, dotted with marriage and divorce, with jazz and booze as the only resource when trouble comes. Pretentious production but unwholesome.

NOTICE OF AWARDING CONTRACT

NOTICE is hereby given to all persons interested, that bids for the furnishing of all labor, tools and materials necessary for the improvement of park property by grading, seeding, constructing drives, walks and drains, removal of obstructions in Block 1, First Addition to Ravinia Highlands and in Block 1, Ravinia Highlands, located in Sections 25 and 36, Township 43 North, Range 12 East of the 3rd Principal Meridian in Lake County, Illinois, were opened on the 21st day of July, A. D. 1930, and the E. A. Meyer Construction Company, being the lowest responsible bidder, the contract was awarded to the said E. A. Meyer Construction Company, on the said date, July 21st, A. D. 1930.

Said bid for the work is as follows:

1. Removal of all obstructions, including foundation walls to a depth of one (1) foot below the surface of the ground, weeding and raking the area to be ploughed, and removal of all rubbish therefrom, complete at Two Hundred Dollars no Cents (\$200.00) 200.00
- 1a. Removal of all existing buildings and structures above the foundation walls, from the site of the improvement, complete at Fifty Dollars No Cents (\$50.00) 50.00

6. 370 lineal feet of six (6) inch tile pipe drain, with open joints, laid at an average depth of three (3) feet; including all trenching, shoring, bracing, pumping, backfilling with earth, thoroughly flushed and compacted, connection to the herein provided storm drain, and removal of all surplus excavated materials, laid complete at No Dollars Sixty Cents (\$0.60) per lineal foot 222.00
7. 540 lineal feet of four (4) inch tile pipe drain, with open joints, laid at an average depth of three (3) feet, including all trenching, shoring, bracing, pumping, backfilling with earth, thoroughly flushed and compacted, connection to the herein provided storm drain, and removal of all surplus excavated materials, laid complete at No Dollars Fifty Cents (\$0.50) per lineal foot 270.00
8. 4 catchbasins constructed of monolithic concrete or concrete blocks, walls and bottoms six (6) inches thick, overall height of concrete six feet six inches (6'6"), inside diameter four (4) feet. Concrete composed by volume of one (1) part Portland cement, two (2) parts sand, and four (4) parts gravel or crushed stone, mixed with sufficient water. The concrete composed by volume of one (1) part Portland cement, two (2) parts sand, and three and one-half (3 1/2) parts gravel or crushed stone, mixed with sufficient water; including expansion joints where said pavement joins existing concrete pavement and end plank where said pavement meets dirt roads; including a surface coat of tarvia or its equal, using one-half (1/2) gallon to each square yard, and one-half (1/2) inch layer of cleaned gravel rolled in place, and including curing by two (2) pounds of calcium chloride per square yard of pavement, and including backfilling between the back of the integral curb and the westerly right-of-way line of the Chicago & Northwestern Ry. Co., with crushed stone, and along alley edges of the pavement, with earth, constructed complete at two Dollars Fifty Cents (\$2.50) per square yard 8,125.00
11. 445 lineal feet of integral curb, twelve (12) inches wide at the top, three (3) inches high above the surface of the pavement; the exposed face of said curb shall be rounded at the top along a curved line having a radius of twelve (12) inches, and at the bottom along a line having a radius of thirty-eight (38) inches. The concrete to be composed by volume of one (1) part Portland cement two (2) parts sand, and three and one-half (3 1/2) parts gravel or crushed stone, except that the exposed surface to a depth of one-half (1/2) inch shall be of mortar composed by volume of one (1) part Portland cement and two (2) parts sand, both mortar and concrete mixed with sufficient water. Said curb shall be provided with one-half (1/2) inch expansion joints continuous with the expansion joint in the pavement, and cured as described for the pavement; constructed complete at No Dollars Forty Cents (\$0.40) per lineal foot 178.00
12. 1180 lineal feet of integral curb,

- six (6) inches wide at the top, three (3) inches high above the surface of the pavement; the exposed face of said curb shall be rounded at the top along a curved line having a radius of twelve (12) inches, and at the bottom along a line having a radius of thirty-eight (38) inches. The concrete to be composed by volume of one (1) part Portland cement two (2) parts sand, and three and one-half (3 1/2) parts gravel or crushed stone, except that the exposed surface to a depth of one-half (1/2) inch shall be of mortar composed by volume of one (1) part Portland cement and two (2) parts sand; both mortar and concrete mixed with sufficient water. Said curb shall be provided with one-half (1/2) inch expansion joints in the pavement, and cured as described for the pavement, constructed complete at No Dollars Thirty-five Cents (\$0.35) per lineal foot 395.50
13. 1000 cubic yards of excavation for the concrete pavement, including preparing the subgrade and removal of all surplus excavated materials, complete at No Dollars Seventy-five Cents (\$0.75) per cubic yard 750.00

PUBLIC NOTICE

Public attention is hereby called to the ordinance of the City of Highland Park which declares thistles, burdock and other noxious weeds public nuisances. The people of the city are urged to co-operate in eradicating this nuisance from the city. Such action will be a particular benefit to sufferers from hay fever. The ordinance is as follows:

"1211. Weeds, Etc.—Nuisance—Penalty: S. 6. Cockle burrs, thistles, burdock, wild lettuce and other noxious weeds her-by are declared a nuisance and whoever shall suffer or permit such weed or plant to grow or be in or upon any premises in the City of Highland Park owned or controlled by him or her shall be guilty of maintaining a nuisance, and shall be subject to a fine of not less than five dollars (\$5.00) nor more than twenty-five dollars (\$25.00) for each offense, and a like fine for each week such person shall continue to keep, suffer, permit or maintain such nuisance after the first conviction." 21
