Indications that agitation in the war department relative to the closing up of the Great Lakes Naval Training station has been definitely Delegates from Lake county will go dropped and that the station will continue to function as at present, were forthcoming last week when the war department announced plans to disstations as an economy move, says the Waukegan News-Sun.

The plans call for the consolidation of several stations, the closing down of others and the sale of all obsolete and unnecessary equipment. Some months ago the reports stated that Twenty delegates and alternates the Great Lakes Naval Training station was in the paring knife's line of retrenchment, but the report caused such a furore among naval dignitaries and midwest residents that the plan was silenced.

As many as a dozen yards and shore properties no longer considered necessary to the efficient operation of the naval establishment face elimination or drastic curtailment of activities, largely as a result of an exhaustive study of naval activities made by Assistant Secretary of the woman to gather support among the Navy Ernest Lee Jahncke and chiefs of bureaus of the navy.

Issue to Finance More

Plans for a conference with Mayor L. J. Yager of Waukegan, to be followed by a joint session with the Waukegan city council, concerning location of the proposed \$1,000,000 sewage disposal plant in that city, a dispute unsettled for many months, was decided upon at a meeting of the North Shore Sanitary District board last week in Waukegan, preparatory to selecting a date for the bond issue election.

The tentative dates for submission of the question of erecting seven new plants in the district to the voters are either Oct. 2 or Oct. 9, John Oliver of Highland Park, president of the board, said after the meeting, but this depended to a large extent on the outcome of the conference with Mayor Yager and later the council, a settlement concerning its location first being mandatory, he explained.

Should the issue carry, but Waukegan vote against it, the plant in that city would not be erected at this time, according to the board. It is probable that an educational campaign to point out the evils of polluting the lake by sewage will be carried on, and the board is contemplating such a plan.

The other plants proposed, at Winthrop Harbor, Zion, North Chicago, Lake Forest, Lake Bluff, and Highland Park, would, however, be erected at once, the board states.


