THE PLATFORM of the Crusaders

The Crusaders believe that the control of liquor should be vested in State rather than National government.

The Crusaders will work toward this goal with the belief that the most practical method of accomplishing this work:

1. Repeal of the present Enforcement Acts —the Volstead Act and the Jones Law.
2. Passage by the States of the laws which will control the manufacture and sale of intoxicating liquors along the lines best suited to the problem of each individual state.
3. Federal legislation to protect states which may desire to remain dry from liquor importation.
4. Repeal of the eighteenth amendment which any plan of prohibitory reform makes essential so no future congress may nullify these acts.
