Expatriates' Attitude on Tariff Arouses Ire of Chindblom, Report

Much perturbed by what he declared to be unwarranted criticism of the tariff not by Europeans but by Americans living in Europe Congressman Carl R. Chindblom presented an extensive report on business conditions over seas in a report to President Hoover, according to news dispatches from Washington.

"Much of the criticism that has been directed against our tariff measures from the other side," he declared, "comes not from Europeans

but from representatives stationed abroad by American importing concerns.

"I told the President," Mr. Chindblom went on, "how thoroughly disgusted I was with Americans abroad who apologize for the tariff bill and denounce in their dealings with Europeans. On the other hand I heard no criticism of the tariff bill by Europeans."

Mr. Chindblom states, however, that there is not half the depression and unemployment in the United States as in England or Germany, France seems fairly prosperous.

Several new species of plants were discovered recently by Paul C. Standley, associate curator of the herbarium at Field Museum of Natural History, while making determinations in a collection of 500 specimens from Brazil of the madder family (Rubiaceae), sent by the Royal Museum of Stockholm.
