State's Attorney in Report of Fines Gives Figures For 9 Years

Fines totalling \$13,158.50 were collected by State's Attorney A V. Smith from Jan. 27 to Aug. 26 from persons arrested in vice raids during that period, according to the report filed with Judge Edward D. Shurtleff and on record in the circuit court.

In addition to the fines assessed by justices of the peace, \$455 was charged for fees, making a total of \$13,613.50.

All of the fines received by Col. Smith have been placed with County Treasurer Jay B. Morse, making a total of \$472,000 in the nire years he has been state prosecutor.

State records show that the amounts received by Lake county during Col. Smith's term of office are the largest of any county in Illinois, except Cook county.
