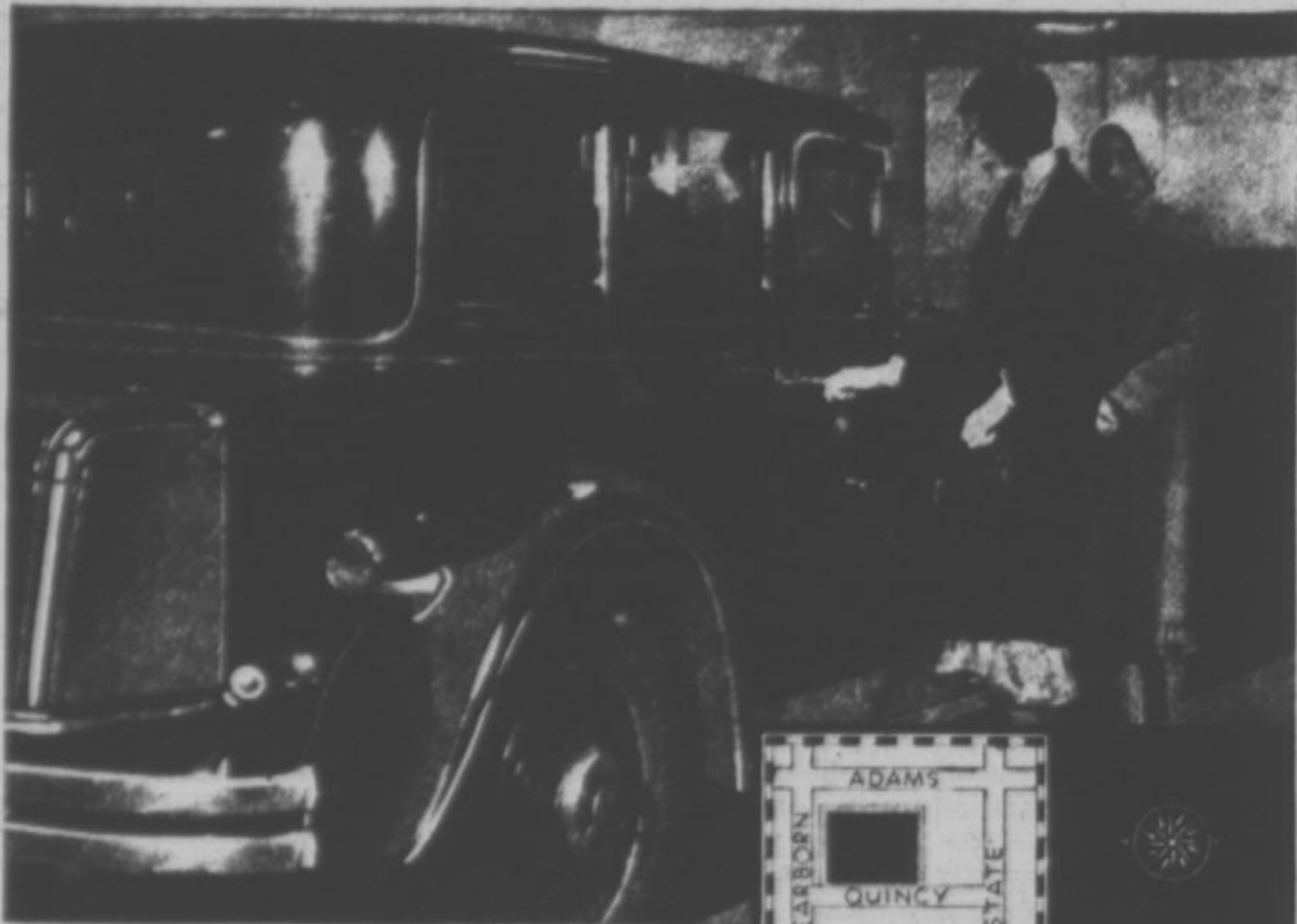

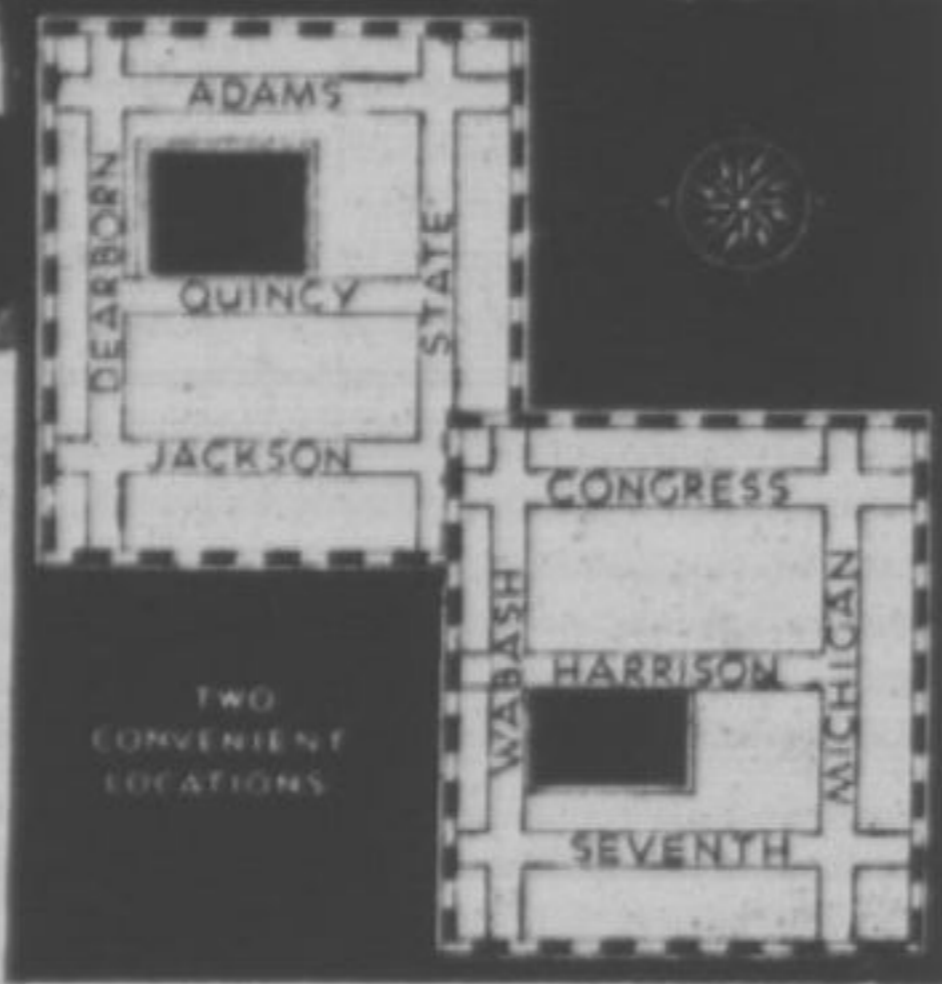

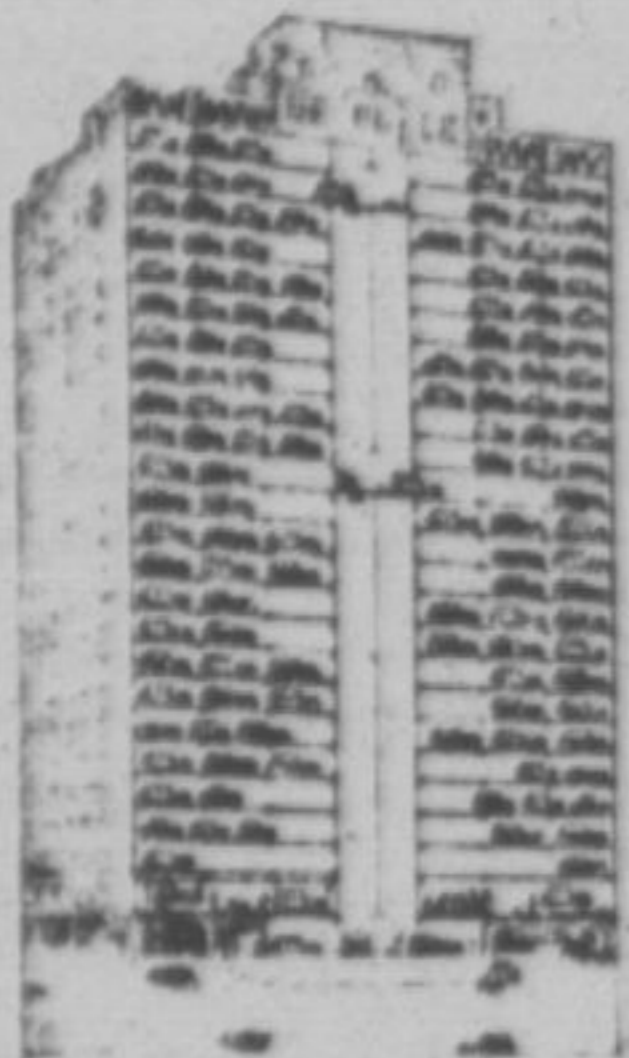

BRIEF NEWS ITEMS FROM LAKE COUNTY

Interesting Happenings About This Part of North Shore; County Seat

William Woodard, long active in affairs of the Sharvin post of the American legion, North Chicago, was elected commander of that organization last week at the election of officers.

Mrs. Christ Alwardt, who had resided in Waukegan for the last 45 years, passed away at the home of her daughter, Mrs. Arthur Johnson, of McKinley, last week.

Construction on the Waukegan postoffice will be started as soon as conditions permit, John W. Philp, assistant postmaster general, declared in a letter received by the Waukegan Chamber of Commerce.

A burglar, with a penchant for women's shoes and hose, broke into the rear door of the Feltman-Curme shoe store, 116 N. Genesee street, in Waukegan, last week. He stole a number of women's shoes, silk hose and several pairs of spats.

Ampelio Castaneda, 22 years old, slayer of Guadalupe Gonzales and Julio Guerrero, at 513 Market street, in Waukegan, October 7, 1927, last week was denied a pardon or commutation of sentence by Governor Louis L. Emerson.

Slugged across the head by a blunt instrument, Emil Niosett, of the Naval hospital at Great Lakes, last week was robbed of \$35 and a watch worth \$65. He was picked up by police officials in front of 504 South Genesee street, Waukegan, and taken to the station.

Judge Edward D. Shurtleff of the circuit court of this district has been elected president of the Federation of Bar Associations for the sixth supreme judicial district of Illinois. He succeeds Circuit Judge Arthur E. Fisher of Rockford, who was named as member of the board of governors for the state bar association for one year, representing this district in the state group.

Amateur burglars who smashed a window to gain entrance into the Grand Cleaners and Dyers, Libertyville, last week, overlooked fur coats valued at thousands of dollars, other valuable wearing apparel, and a cash box containing \$5 in cash, escaping with a man's suit, a pair of trousers, and a woman's dress as their only loot.

Tax Reform Movement Spreads in County

The movement started by Highland Park civic leaders to have taxes equalized throughout the county seems to be gaining headway throughout the county, says the Waukegan Times.

Township assessors are laying plans for a meeting at which they will attempt to use more scientific and accurate methods so that the burden can be made uniform.

Valuation of land of a similar nature and market value often times is assessed at widely ranging prices, according to Supervisor Harry Stratton, of Lake Villa, chairman of the board of review.

In Shields township on the western boundary there are farms that are assessed \$200 an acre, while right across the line in Libertyville township the assessment runs but \$50, according to Stratton.

Large numbers of persons are evading the personal property tax, Stratton charged, and he pointed out that the worst violators are those owning both Cook and Lake county property.
