Six Questions

The second ballot will bear six questions to be voted on including the three relating to the liquor question. And the third ballot will have the state forest conservation proposition.

There are to be 62,100 of each ballot distributed among the precincts in the county, or a total of 168,300. There are approximately 40,000 voters in Lake county. According to the state provisions each precinct must be allowed as least fifty per cent more ballots than there are voters.

Lake county, which has a third class rating for voting purposes in Illinois, will hold two registration days. The first registration day will be on Oct. 14 and the second will be a week before the election, Oct 28.

Voters at the Nov. 4 election must have been a resident of Illinois for at least one year, a resident of the county in which they vote for at least three months and in the precinct for at least 30 days.
