Machine Gun Stolen from Fort Sheridan Is Found in Canal

A machine gun, stolen from Fort Sheridan by a former soldier who hoped to sell it to Chicago gangsters was recovered late last week from the sanitary district canal at Howard street and McCormick road after its location had been revealed by Mrs. Leota Brown, 1135 N. Dearborn street, Chicago, whose son, Wayne C. Bowlin, is in the guard house at Fort Sheridan, charged with its theft.

Bowlin, a former soldier was arrested by army authorities following his release from the Bridewell where he served 80 days on a charge of carrying concealed weapons. He had been arrested carrying a blackjack. He was dishonorably discharged from the army following his arrest on this charge.

A long period of investigation at Fort Sheridan following the disappearance of the machine gun finally traced it to Bowlin. Bowlin admitted to army officials that he had taken the gun and hidden it at the home of his mother. Mrs. Brown said the gun had been thrown into the sanitary district channel by another son, Louis, and she pointed out the spot to army officers.

A detail was assigned to drag the channel and the machine gun was recovered.

Suspicion was first directed to Bowlin by the confession of Private James Wolcott, who was responsible for the missing machine gun. He admitted that he had allowed Bowlin to take it. Bowlin was offered \$200 to obtain the machine gun by Chicago gangsters, he said.

Women Push Constable from Running Board of Auto; He Is Badly Hurt

After chasing two women from Waukegan to Libertyville, where he received the assistance of Mayor Earl Corlett, Constable Frank J. Sherry of Waukegan was shoved from the running board of a moving car and badly injured last week.

The women had been sought on a writ of attachment obtained by Al Ahart before Justice Harry Hoyt. Ahart claimed that the two owed him for rent.

Sherry tried to serve them here, it was understood, and they left in an automobile with Sherry pursuing them. At Libertyville he sought the aid of the police and Mayor Corlett went to his assistance.


The constable jumped on the running board of the machine and tried to bring the two to a halt, he claimed when one of them struck him and bowled him to the pavement. Sherry's head was badly cut, and he received cuts and bruises about the body.

State police caught the women near Half Day and brought them back to Libertyville where they were given a hearing in justice court.
